6	RELATING TO POSSESSION OF CONTROLLED SUBSTANCES; REPEALING SECTION
7	16-15.1 SFCC 1987 AND ADOPTING A NEW SECTION 16-15.1 TO PROHIBIT THE
8	INTENTIONAL POSSESSION OF MARIJUANA AND SYNTHETIC CANNABINOIDS.

10	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:
11	Section 1. [REPEAL] Section 16-15.1 SFCC 1987 (being Ord. #2005-7, §3) is
12	repealed.
13	Section 2. A new Section 16-15.1 SFCC 1987 is ordained to read:
14	16-15.1 [NEW MATERIAL] Intent; Marijuana; Synthetic Cannabinoids; Possession
15	Prohibited.
16	A. It is unlawful for a person intentionally to possess one ounce or less of marijuana. It
17	is not a violation of this Section for a person to possess marijuana obtained pursuant to a valid
18	prescription or order of a practitioner while acting in the course of his professional practice or as
19	authorized by the Controlled Substances Act, Section 30-31-1 NMSA 1978.
20	B. It is unlawful for a person intentionally to possess one ounce or less of synthetic
21	cannabinoids for the purpose of causing a condition of or inducing symptoms of intoxication, elation,
22	euphoria, dizziness, excitement, irrational behavior, exhilaration, stupefaction or dulling of the senses,
23	or for the purpose of, in any manner, changing, distorting or disturbing the audio, visual or mental
24	processes.
25	C. A person who violates this section shall, for the first offense, be guilty of a petty

1	misdemeanor and shall be punished by a fine of not less than fifty dollars (\$50.00) or more than one
2	hundred dollars (\$100) and by imprisonment for not more than fifteen days.
3	D. The municipal court does not have jurisdiction over subsequent offenses.
