Councilor Rivera asked how much the City spent on the sound system, etc. last year.

Mr. Siqueiros thought it was \$12,000 year to date and expected to use the rest for the remainder of the year.

Councilor Rivera asked if they requested another \$50,000 for this year. Mr. Siqueiros agreed.

Councilor Rivera wondered at what point does it made more sense to use the City's own stage and sound system after spending about \$100,000 for last two years.

Chair Wurzburger thought they could speak to that now.

Mr. Siqueiros said he did look at it pretty intensely two years ago and they were worried about having staff to install and tear down and store the equipment at each of the events. There were many more events - almost weekly in the summer. He said he could do a comparison.

Councilor Rivera thought that would be good idea to look at.

Chair Wurzburger noted that Sandra Brice was present.

Councilor Trujillo recalled he got a resolution passed a few years ago about movies in the Park (Railyard) and the object was for the City to own its own equipment and the movies could move around the City. He didn't know where that resolution went to. Maybe he could resurrect that resolution.

Ms. Brice clarified that only about \$25,000 would be allocated to stage and sound set up. So it was far less than the total. Stage was about \$10-12000 per year for rental. The Railyard Park Stewards looked at what other cities did and it was quite costly and she was concerned about the flexibility if they had it all set up because they used the park in a variety of ways. Santa Fé A-V owned the digital movie equipment and was another half of the package. The costs included the crew.

Councilor Rivera wasn't thinking of a permanent stage.

Ms. Brice said they had a stage and it takes four men to put it up in about a day.

Councilor Rivera asked if the committee could get the information back in time to make a decision.

Mr. Siqueiros said it was to go to Council this Wednesday.

Councilor Rivera didn't want to hold it up but wanted to know the costs for purchase of that equipment.

Councilor Calvert suggested the Committee could move this on to Council and could apply the money to that if it was feasible.

Chair Wurzburger noted it would only lose two weeks.

Councilor Rivera moved to approve the request with direction to staff to research buying the equipment. Councilor Calvert seconded the motion and it passed by unanimous voice vote.

Mr. Ed Vigil presented the request.

Councilor Calvert had a question that was answered in the schedule.

Councilor Calvert moved to approve the request subject to the HDRB approval.

Chair Wurzburger noted that between Finance and Council Public Works could hear it then for final voting.

Mr. O'Reilly said this matter did go to HDRB at their last meeting and was postponed to tomorrow. They had issues with the design proposed by the applicant and the Land Use Department had some issues with the amount of sidewalk that would be lost if approved.

Chair Wurzburger said HDRB's job was different from this Committee's job. Let's focus on our job. She asked if the Committee needed to hear it again rather than Council.

Mr. O'Reilly said this would have to come back for final recommendation and then to Council for final approval. This was just conceptual.

Councilor Calvert said it would be nice to have a better drawing of it. He knew this was a draft but the one page was hard to read on reconfiguration. He didn't think he read about the sidewalk in the packet.

Mr. O'Reilly said the applicant proposed to change the roof space into a deck space and wouldn't need to go beyond HDRB approval. But he wanted to build out over the city sidewalk with seating above. That would require a lease from the City like at the Marble Brewery. There was also zoning approval as well as HDRB.

Councilor Calvert thought zoning was administrative.

Mr. O'Reilly agreed and the ability to do it was in question. This was a chicken and two egg process.

Public Works/CIP & Land Use Committee March 25, 2013

They wanted a concept of the air space lease.

Councilor Calvert moved for approval of the concept like Marble Brewery but with direction to get the other statements. Councilor Trujillo seconded the motion.

Councilor lves noted in the memo that it referred to conditions in the lease agreement like those on the upper deck on north side. He asked what those conditions were.

Mr. Vigil said under Section 2, the use of premises were limited to food and beverage service and limits on lighting.

Councilor lves understood the proposed initial term was five years. He asked about costs of the improvements.

Mr. Vigil wasn't sure but they would be substantial.

Councilor lves suggested the City had the right to remove those at end of lease.

Mr. Vigil agreed but it was only 267 sq. ft.

Councilor lves said he would benefit from zoning and HDRB input with the understanding this was concept approval and coming back. He also would like to look at the lease for the north side if it was a touch point for this discussion.

Mr. Vigil agreed to provide that to him.

Chair Wurzburger said the concept was to look at the fact that it used air space. Sitting upstairs looking across at the plaza was a very good idea. The HDRB was hopefully making the decision based on their purview. Since it was conceptual plan the Committee must look at it from that perspective.

The motion passed by unanimous voice vote.

Councilor Calvert understood that the sponsor would like it to be this way but the City Attorney's opinion was that this was not proper.

Ms. Brennan said the opinion of the City Attorney had not changed in this regard.

Councilor lves said in the context of matters before district courts when it gets appealed upward there were parties of interest and perhaps some feeling that there should be opportunity for an advocate to step in on behalf of that entity. He had troubles with the person of that entity and guidance from the City Attorney's office. He asked what the alternatives were. If there was a split vote in the Commission he wondered if they would have a representative of each side.

Ms. Brennan believed Council could not legislate it away. There was at least the appearance of partiality on the part of the Board or Commission. It could come because the committee trusted the board more or less. Most cases have advocates on both sides, especially with the HDRB. And there were organizations like OSFA that could speak and there were planning groups that take an interest and could show up. Sometimes staff might not make a full throat presentation of it to Council. She thought there were opportunities for boards to get their impressions across and an opportunity to explain their decision.

Councilor lves agreed that was first and foremost the way to explain their position on the decision. An advocate was a helpful thing that the issues were fully heard and vetted to Council. So whereas it might not be good to have a member of the body then someone else could be able to stand up for that body. So it was an imperfect circumstance that he would like to find a way to do better.

Councilor Calvert thought there were two opportunities. One was by the findings and conclusions and also by the minutes so the boards and commissions needed to review them and reflect on what they did. He didn't support this

Councilor Calvert moved to disapprove the request. Councilor Rivera seconded the motion and it passed by majority voice vote with all voting in favor except Councilor lves who abstained.

Ms. Byers provided a handout [attached as an exhibit].

Ms. Byers explained that she put the wrong information in the packet that went to POSAC and briefly explained the MRC \$25 fee. POSAC approved amendments to the bill which were listed.

She met with Councilor Dominguez and Mr. Pino and city staff. There were several amendments to the proposed ordinance. This bill separated out MRC because of debt service that required certain levels of payment. There was a very detailed impact report on page 13 and several tables. The first table showed collections in past years to date and how those were used for cleaning and maintenance. \$8,250 were collected in league and user fees. She quoted the fees requirement that the City had not been charging in the past. The \$8,250 with the new fee structure would go up to \$26,000.

She said Councilor Dominguez also wanted to show in Table A the costs for the five fields used by youth leagues and compared it to how much it cost to water these fields (over \$1 million). He proposed a voluntary additional amount on water bills.

Chair Wurzburger asked, since the handout was so different from packet, if the Committee could discuss it or if they needed to postpone it.

Ms. Byers clarified there was no notice problem since it would go to other committees.

Chair Wurzburger said they had not had the chance to look at it either.

Councilor Trujillo said this all went back to the City not doing its job. They had an ordinance enacted in 2006 that set fees and league fees and for some reason they were never implemented. Two years ago he discussed it with staff and then sponsored an ordinance change two years ago.

He was shocked that no league officers were present at this meeting. They were saying he was being bad in making them pay for it. But that wasn't true. What he wanted was to give the kids a safe place to play sports. Councilor Dominguez was suggesting doing away with the fees. But just look at the water costs - \$324,976 for water at Borrego Park alone last year. What The City got in fees didn't put a dent into those expenses. And the City was doing the leagues a favor by taking care of the field. Lots of leagues said it was too hard for them to collect a fee.

His biggest concern was an ordinance passed two years ago that all leagues turn in a financial report and didn't think any of them had been submitted. He asked Mr. Pino who was in compliance.

Mr. Pino said the memo went out in the fall and in January all the leagues except YAFL had submitted them. He was told that YAFL was contacted twice after that.

Councilor Calvert concluded that because the City hadn't taken care of the ordinance enforcement it was now a problem. He asked if it was \$12/person.

Councilor Trujillo agreed but there were some families who had their kids in multiple sports leagues. They were separate organizations. \$12 was not a steep price considering the facilities they were using. He had mentioned to Councilor Dominguez that the City was trying to build SWAN Park in his district and there would be sports at that park. They would have the same issues.

So he was not in favor of this ordinance. Leagues didn't want to go out there and clean the park. In the New Mexican it was reported they were willing to pay more but that wasn't said at the public meetings. It was too bad Councilor Dominguez couldn't be here for the discussion.

Councilor Calvert was a little puzzled by POSAC's action who agreed to approve it but only with lots of amendments. Obviously the fees had little impact but the City had to charge something so the organizations would be serious about their use of the facilities. Without a fee there would be a free for all out there. The City charged a league fee but he was not sure why they had to pay something on top of that. That was more complicated than it needed to be. He wasn't sure what Councilor Dominguez was proposing now was significant enough.

Councilor Trujillo said it was a \$25 fee for the entire league. It was just paid by the league. Ms. Byers agreed.

Councilor Calvert felt that wasn't worth doing the paperwork for it.

Councilor Rivera said as a past coach and past board member it was frustrating that the city painted the field and when the grass grew it had to be painted again. He thought a per team fee would be appropriate but the per player fee created a burden on the leagues and the individuals. It got costly for kids who were in several leagues. It also cut into individual scholarships.

Councilor lves understood that the MRC was in a different circumstance. He asked what the amount of the debt service was at this time.

Ms. Byers wasn't sure but it didn't touch the debt service. However, the City was required by the bond ordinance to charge fees.

Mr. Pino said they were putting it together on the budget right now.

Councilor Rivera added there were only certain sports that could be played at MRC and for those who loved to play those sports the fees would be different at MRC than what was charged in the City.

Councilor Trujillo thought that might be where they should look at league fees. He figured the room would be packed with people here. He wanted to reach out to the leagues and postpone it tonight for a public meeting next time so they could hear what the leagues really wanted.

Councilor Trujillo moved to postpone this request for a public meeting at the next Public Works Committee meeting. Councilor Calvert seconded the motion and it passed by unanimous voice vote.

Chair Wurzburger thought they should have it toward end of the meeting as 5:30 might be too early to get the public here. The Committee had general agreement.

Councilor Calvert asked the committee to work with the sponsor on modification when it comes back for more consensus. It was too complicated right now.

Councilor lves asked what fees were charged at the Marty Sanchez Golf Course for students.

Mr. Gurulé wasn't sure what was charged to them.

DISCUSSION AGENDA

19. REQUEST FOR DISCUSSION AND DIRECTION TO STAFF REGARDING THE PUBLIC WORKS LLC INFORMATION (ISAAC PINO)

Chair Wurzburger reminded the Committee it was at a previous meeting to do a study for cost savings across the board. She was curious if they could develop some direction to staff. If they were to use an RFP, they would have to say they were looking for someone to do it "under these conditions." She asked for any opinions.

Councilor lves thought the way the proposal came seemed to be a win-win circumstance and with assurance it would pay for itself. It obviously needed careful coordination with someone looking over your shoulder but if it could make the use of public dollars more efficient and without savings it wouldn't cost the City anything.

Councilor lves moved to direct staff to explore how to pursue the idea including a possible RFP. Councilor Calvert seconded the motion.

Councilor Calvert asked if certain departments could be moved to the head of the line.

Chair Wurzburger understood it would be exemplary rather than prescriptively done.

The motion passed by unanimous voice vote.

20. MATTERS FROM STAFF

There were no matters from staff.

21. MATTERS FROM THE COMMITTEE

Councilor Rivera thanked the crews that cut the Chamisas on Valentine's Road with special thanks to Ben Gurulé.

Councilor Trujillo asked if the parks now had water.

Mr. Pino said that was starting soon.

22. MATTERS FROM THE CHAIR

Chair Wurzburger wanted to have the cost information for Alameda sidewalks and down to the river and when it would be finished. This project caused her to question if they needed sidewalks on both sides. She was curious it and looking across the river, she regretted that she couldn't recall where they were going to fix that side. She asked if there was such a plan.

Mr. Pino didn't know and asked if she was talking about the Plaza del Rio.

Chair Wurzburger said was talking about Alameda all the way to Calle Cabra. They already did Delgado.

Mr. Pino asked if her preference might be on the south bank.

Chair Wurzburger clarified that she just wanted to know what the plan was there. She questioned if they needed a sidewalk on both sides of the river.

Chair Wurzburger announced she could not do the Thursday trip this week.

Ms. Mossman said they were going to the airport on Thursday. She asked the members to let her know if they could go or they would we would reschedule it for a week later.

Sports Field Use by Leagues and Schools

SPONSOR(S): Dominguez

SUMMARY: Article 23-7 SFCC 1987 relates to the MRC user fees and rates for the golf course and for sports fields at the MRC as well as other sports fields throughout the city.

A working draft of the proposed ordinance amendments was reviewed by the Parks and Open Space Advisory Commission ("POSAC") at their February 19, 2013 meeting. The working draft included amendments to the youth league fees for sports fields, other than the MRC, to require a \$25.00 permit fee and a \$5.00 per team fee for each youth league, plus each league would have been required to volunteer for two volunteer clean-up days per season.

After hearing public comments, POSAC approved the working draft of the proposed ordinance amendments with the following amendments:

- The volunteer requirements of the ordinance be removed; and
- The fees remain the same as what is currently being paid or a modest increase in such fees

Currently, the proposed ordinance amendments include:

- Amending article 23-7 to distinguish between MRC sports fields and other city sports fields
- Amending the submittal requirements for all leagues that request to use MRC sports fields and other city sports fields
- Creating a new section 23-4.12 SFCC 1987 to establish regulations, fees and rates for city sports fields, other than MRC sports fields
- Provides that youth leagues and schools who use sports fields, other than the MRC, pay a \$25 permit fee and mandates that representatives from each league or school send representatives of the league or school to an annual clean-up day(s) sponsored by the City
- Creating a new section 23-4.13 SFCC 1987 to establish a voluntary sports field maintenance fund.

Ms. Hansen moved that the Parks staff and interested citizens or organizations work together to drait an MOU to work on the trails and parks.

Ms. Taylor made a friendly amendment that the motion includes the phrase "topic presented and discussed with the City Manager, the Parks Director, POSAC and the Legal Department."

Mr. Lehm seconded the motion and the motion passed by unanimous voice vote.

Chair Booth asked what options there were for the question of liability at the motocross park.

Ms. Boltrek said the City's insurance company risk consultant assessed the park and would respond within 10 days. She said at that point travelers Insurance Company would say if they would insure the park and give mandates with regard to the park being manufed or for required changes.

Chair Booth asked if an option was to get a rider with other insurance companies. Ms. Boltrek replied the preference is with Travelers, which is one of the argest. Other companies could be looked at but the City would still be bound by Travelers recommendations.

Mr. Coriz said the insurance company doesn't have the criteria to properly assess the parks or motocross; there are no national standards.

The group discussed the process and how other parks are insured. One-idea was for the City to lease the land to a nonprofit or a private company.

Ms. Boltrek suggested logoying the Legislature; several states have recreational immunity. Ms. Amer added that currently there is nothing specific in New Mexico law that allows immunity for recreation or hazardous activities

Chair Booth said another option discussed was to lease the land to a nonprofit; the question is where the nonprofit would get the money to pay for insurance.

The goup discussed the possibility of charging for the facility.

. McDonald suggested the Commission wait for the insurance company recommendation.

Copies of the ordinance were made available to those in attendance. (Exhibit 1)

Chair Booth thanked the sports league members for attending and reminded them she is looking for a representative from their community.

Chair Booth asked Melissa Byers from Legal to review the ordinance.

Ms. Byers said the Santa Fe City Code currently distinguishes the MRC and the sports fields. Bonds are sold to pay for the MRC facility and Councilor Dominguez wants MRC separate from fields that are funded by the General Fund.

She said Councitor Dominguez wants to reduce the Youth League fees for fields outside the MRC and proposes a \$25 permit fee per league and a five dollar charge for each team. In addition the leagues would be asked to volunteer two days per season to help clean the park.

Ms. Byers said another piece of the ordinance would establish a donation program to fund maintenance of the sports fields. She said Councilor Dominguez was unable to attend so she would take the Commission's suggestions back to him.

Ms. McDonald said there should be "in lieu of" language so if a league doesn't want to volunteer [to clean the park] there is an option to give the City money for maintenance.

Chair Booth opened the meeting up for public comment at this time.

PUBLIC COMMENT (Revised Agenda Order)

Mr. Paul Grace, president of the Little League, said he met with Councilor Dominguez and Ms. Byers when the resolution was being developed. He said the issue started when the City began to enforce the existing ordinance fees that had never been put into practice for the Youth Leagues.

He understood the MRC ordinance had been created because fees are needed to pay off the bond and the words "and city parks" was added at some point. He said the leagues pointed out at the time that if the fees were put into practice, the leagues couldn't afford to pay them.

Mr. Grace said in the course of discussions, Councilor Dominguez suggested separating the city parks from the MRC.

Mr. Grace said he volunteers with other things and he doesn't have two days to clean the parks. He said trying to find a volunteer for almost anything is tough; to find volunteers to clean up a park is twice as tough.

He said he questioned what "clean up the park" means and whose responsibility it is if someone is hurt. He said 14 parks are listed in the ordinance. He asked if volunteers would be called to clean other parks than what the league uses. He said the end result is he or other officials would end up doing the work.

Mr. Grace said the bottom line is the leagues don't want to go bankrupt because of an increase in the ordinance. He said decreasing the fees is great, but isn't really needed. He said the parks are City parks and are not the responsibility of the kids or the leagues.

Mr. Widder Tidmore on the board for Northern Soccer Youth League said all of their games take place at the Downs of Santa Fe Soccer Complex; with leagues hosting practices at various parks around

town. Mr. Tidmore said he is on his league's committee to maintain their field (the Downs) and has a hard time getting parents/volunteers to help.

He said the chances of getting parents to clean a city park is even less and he would end up doing that. He asked what if he doesn't do an adequate job. He said the ordinance is vague about what "cleaning the park" means. He asked what the actual park boundary is and what has to be done and what the standard is of cleaning. He said the standards are unclear and places an expectation that isn't realistic.

Jess Bransford said he is a police officer in Santa Fe who came to support the motocross track. He said the track is the only place in town to ride and now that it is closed, he drives to Albuquerque, Rio Rancho, Espanola etc., to ride.

Chair Booth thanked Mr. Bransford. She explained he may have missed the previous conversation about looking at the insurance. She said the Commission would move forward with other options and is very supportive of keeping the track open.

Mr. Mike Baker said he is in favor of the track. He said there are a lot of people with motorcycles and ATVs and if they had a place to ride the enforcement for the City/County would be more draconian for violators.

Chair Booth said she is hearing that the fees are not the issue, but the two volunteer days is onerous. She asked if Parks staff had comment about people volunteering to maintain the sports fields.

Mr. Ortiz said Parks drags and lines the fields and picks up trash and mends fences. He said Parks would have to look at what was meant by *maintenance*.

Mr. Grace asked in a park like Franklin Miles, if that means that the Little League who uses the baseball/softball fields would be obligated to clean the skate park portion, the basketball courts, the picnic area, etc. He said there is a lot of uncertainty about the requirement but that is secondary to getting people to volunteer.

Mr. Grace said there might be an imbalance in terms of what one sport/league pays versus another. He said if the per park fee as part of the permit is standardized, that shouldn't be a problem.

Chair Booth asked if the priority for youth sports would go away; is there is a resolution that the priority is youth sports first, then adults.

Mr. Grace said in practice, the AABC people were told youth sports is priority for Ragle and Ft. Marcy, but he talked with Tommy Martinez who said it isn't working out like that.

Ms. Hansen suggested the preference could be added to the ordinance.

Chair Booth said the provision to allow citizens to voluntarily contribute to a sports field maintenance fund on the utility bill sounds like a good idea. She said however; the City must distinguish between commercial enterprises like the Santa Fe Fuegos and other sports teams that would benefit.

Chair Booth said her major issue is the equity issue of charging youth etc. at MRC differently than what is charged at other parks.

Mr. Isaac Pino provided an example at Genoveva Chavez Community Center (GCC.) He said there are private swim teams that reserve lanes for practice and for 35 years the Santa Fe swim team was the Santa Fe Seals, thought no one knows how they got the designation. He said the designation allowed the Seals to rent lanes for close to nothing.

He said at the same time the Santa Fe Aquatics, another swim team, paid full price and the issue of equity came up. City Council removed the Santa Fe Seals designation and said the Seals would be treated like everyone else and they now pay the same rate.

Mr. Pino said the leagues that generally use the MRC are the Mexican Soccer Leagues etc. and they could make the same case. He said the MRC has to pay the debt service and if fees are lowered it would hurt.

Ms. McDonald said to swim at Salvador Perez costs less than to swim at GCC, so there is precedence for differences when things are constructed at different times and there is a hierarchy of facilities.

Mr. Pino said that was an excellent point. When GCC opened it was an enterprise fund and was to support itself and it isn't any longer. The fees were set to take advantage of the volume of people. He said Salvador Perez and Ft. Marcy, being older, didn't have the same requirements.

Chair Booth said in terms of quality of the facilities, the parks just renovated are in better shape. She noted that the only soccer fields for competitive use are at the MRC.

Ms. Byers said the ordinance states that the same fees charged at the MRC should be charged at all parks. She said she didn't believe that was the case.

Mr. Pino said the City learned about league inequities with charges and permits when Councilor Trujillo asked that the ordinance be enforced.

Ms. McDonald suggested there could be a way to base the fee on the number of players. Mr. Grace explained that the fee for the last couple of years is based on a base permit fee plus x dollars per team and the number of participants is taken into account.

Ms. Byers said she would take what she heard back to Councilor Dominguez and ask if he would like her to make amendments to the ordinance.

Ms, McDonald said the fees should stay the same or a modest increase and the volunteer requirement should either be removed or have an "in lieu of."

Ms. Hansen moved that POSAC recommend to Councilor Dominguez that 1) the volunteer portion of the ordinance be removed and 2) the fees remain the same as what is currently being paid or a modest increase. Ms. Taylor seconded the motion and it passed by unanimous voice vote.

Mr. Pino suggested "what people are paying" should be changed to "what is required in the ordinance."

Ms. Hansen responded that she was clear about stating "what people are paying" because it is different than what is said in the ordinance.

The Commission and attendees discussed the current fees paid by leagues and that what the current ordinance requires is not what is currently paid.

Ms. Taylor said the fees are inequitable.

The group discussed whether the fees were equitable and the services provided were the same.

Mr. Pine said the numbers show about \$57,000 a year collected in revenue and about \$940,000 worth of work. He said this isn't a revenue or profit situation.

Ms. Taylor said the City has an obligation to provide recreational facilities and that will always have to be subsidized. She said her point is that if each team has 10 players and uses the field(s) 50 times, the same fees should be paid by each.

Chair Booth said for the record, it still seems inequitable that children that play at MRC are charged and children who play in all other City parks are not charged. She said the adult teams that play at MRC should not be charged more than adult teams who play in the other parks.

Bette Booth - Community Gardens



Chair Booth said there was a garden council meeting and a second meeting would be held in April. The minutes of the meeting were available to everyone.

She said the Trail Coordinator position would be discussed at DFAC (Bicycle Trails Advisory Committee) the following day. She planned to attend the meeting to give her personal opinion and encouraged others to do the same

Joe Lehm: DeVargas Skate Park

Mr. Lehm said he was involved with a Bosey (?) program and he would talk with BTAC once they have the coordinator position. He said the program could also help at the BMX shop.

He said DeVargas has a dure 15 grand opening date. A meeting would be held at his house at 3:30 with Creative Santa Fe and members of the skate park community to talk about the grand opening event. He suggested a group ride through the Rail Yard.

Chair Booth said she contacted ASD and Grindline and has heard back from ASD.
