1. Roll Call – Chair Trujillo called the meeting to order at 4:10 pm. Roll call did not reflect a quorum until approximately 4:15 pm. The meeting was held in the City Council Chambers, Santa Fe, New Mexico.

Dr. Mier moved to approve the agenda as presented, second by Dr. Lewis, motion carried by unanimous voice vote.

3. Approval of November 20, 2012 Minutes

Mr. Mizrahi moved to approve the minutes of November 20, 2012 as presented, second by Dr. Mier, motion carried by unanimous voice vote.

- 4. Old Business None
- 5. New Business
 - A. Request to fund a 10 person Wildland Hand Crew from reimbursements (Fire Chief Barbara Salas/Erik Litzenberg) (Exhibit A&B)

Memo dated December 7, 2012 outlining the details of the request for the 10 person Wildland Hand Crew from reimbursements. Chief Litzenberg informed the committee that the Santa Fe Fire Department lost grant funding from the New Mexico Youth Conservation Corps. In an effort to keep our current response capabilities the Fire Department is requesting the following:

- Ability to hire 10 seasonal temporary employees for 6 months
- Two Lead Forestry Technicians with benefits and eight forestry technicians without benefits. The total personnel cost for the 6 months is \$156,802.00.

These positions would be paid from the reimbursements obtained through a JPA while responding to Wildland fires throughout the season. The average annual wildland fire reimbursement revenue for the last 3 years has been \$207,619.33.

Page 2 provides a detailed proposed budget. Chief Litzenberg said that they are pursuing a grant from the Water Trust Board Grant and the Valles Caldera National Preserve in hopes to extend the program with an additional 3 months and would result in a budget amount of \$286,802.00.

Exhibit B details the 2012 Accomplishments and the 2013 Requests. In summary, over the last three years the reimbursements have been \$205,000 on average per year and it is expected for that amount to go up by a fair amount. The request to the committee is for support to spend out of that \$205,000, \$156,000 to hire the 10 people for the coming season.

Councilor Rivera asked regarding the grants; is there still a chance that you might not get additional funding? Chief Litzenberg referred back to the YCC grant which they had for the past 3 years, we have been denied that grant. There are other funding resources as outlined in page 2 which are the Water Trust Board Grant and the Valles Caldera National Preserve. The Fire Department has worked with them in the past and they have a grant to work on their property. If they can use our established crew to do that work, it not only gives them a good workforce but it gives us 9 months to have those people available for response in the city of Santa Fe.

Councilor Rivera complimented the SFFD for doing this work and for keeping it going.

Mr. Mizrahi asked where they are housed during the day if they are not out on assignment. Chief Litzenberg said that they don't have a lot of downtime; they are based out of Reclaim State #9.

Dr. Lewis asked if this was a permanent program or something you are just requesting for the next year. Chief Litzenberg said that the last three years have proven that its work is valuable but the request today is for 6 months for \$156,000 out of the reimbursements. Chief Litzenberg ventured to say that once they have proven its worth over the year, the SFFD will be asking for a similar request next year in hopes the powers to be decide that it could work with permanency.

Dr. Lewis asked about the statement of pilot programs and how does the SFFD envision those programs developing. Chief Litzenberg said that there are national standards on how to do the project itself once you get the boots on the ground. One struggle has been deciding where to input the resources. We have been putting our resources into those areas in the community that have been established as high risk. Ultimately we have been doing this work called landscape level. It is believed that the biggest difference can be made when you get in and around the homeowners. There are a number of ways they envision this coming out, 1) education – we do that now but we don't have the resources to be in as many places as they would like to be, and 2) the next step up which is not only education but meeting with the owner and saying, "if you did this, this is the benefit you would see in terms of safety, in terms of beauty and the third step up is actually doing the work.

Dr. Mier asked to clarify if Chief Litzenberg was asking for approval of the \$106,000 for 6 months; would you need to come back to the committee if you have additional funding?

Chief Litzenberg stated that he did not have an answer to that question.

Councilor Rivera asked if we are maximizing our reimbursement rate and also the vehicle, where are we lacking our ability to maximize on the reimbursement.

Chief Litzenberg: Those are great questions; on the last page, bullet three speaks to the answer that you are looking for. One of the problems has been the reimbursement structure through the state. We are trying to renew and establish our JPA with the Forest Service is that they have a really good understanding as to how much it costs to run a program like this. The JPA is in the works and we need this as the mechanism.

Councilor Rivera asked if they had the equipment necessary that would allow them to do the project and maximize the reimbursement.

Chief Litzenberg: I think the short answer is yes in the short term.

Mr. Mizrahi: Earlier this year there was an article in the New Mexican where the homeowners association in Hyde Park Estates was concerned about the activities of brush fires in the dry season. They had called their homeowners together and talked about what trees needed to be removed on their property lines and so forth. Is that an area we do respond to?

Chief Litzenberg: We recognize this area as our response area. This group has spent a fair amount of time there.

Dr. Mier moved to approve the request to fund 1 10 percent Wildland Hand Crew from reimbursements, second by Councilor Rivera, motion carried by unanimous voice vote.

Residential burglaries have decreased significantly from last month report by 42%. The commercial burglaries have also decreased by 13%, auto burglaries unfortunately have increased. Our efforts on residential and commercial burglaries have made it uncomfortable for those who continue in those areas as they are looking for easier targets. Unfortunately too many people are leaving valuables in their vehicles which are tempting and make them quick targets. We are proceeding with Public Service Announcements to remind people to secure valuables, lock vehicles and we are also proceeding with patrols and some new operations in these areas. Overall we are at a decrease with our property crimes with the exception of that spurt we are having with vehicles.

Dr. Mier asked if there were sections of town that are more prone to residential burglaries than others. The Chief stated that it tends to shift but there are some areas are historically high relative to some other areas. A lot depends also on what operations and patrols are

running in an area. Sometimes they will saturate an area. Area 1 is one of the high burglary areas historically; some of the downtown areas are also historically high and a couple of locations on the Southside.

Dr. Mier asked in terms of proximity, are they in neighborhoods where schools are located, does that have any significance? The Chief said that it doesn't appear that the schools are a factor. There are some other factors perhaps proximity to some certain neighborhoods where there are known burglars, proximity to couple businesses where they historically hang out, and things of that nature. But the schools themselves we cannot pin point any direct activity. Dr. Mier asked if there is any time of day that is a normal time for burglaries. The Chief responded that the times of day also vary. It seems that with some of the pressure that is now being put on by the SFPD, crimes are shifting to Saturday and Sunday when people are at church. We are seeing an increase in that area because people are out of the house. Some of these individuals who engage in burglaries are addicts and that doesn't mean they can't figure out ways around the SFPD functions so the department is constantly shifting patterns to be on top of the changes.

Dr. Mier expressed a concern about the lack of concern on some of the residents of this community in terms of the lack of interest in some neighborhoods from shoveling the snow from sidewalks. I think it is important to express our concerns to the city manager that there needs to be some interest in the part of the city to enforce and to remind residents that they need to keep the sidewalks clean. People are forced to walk on the street vs. the sidewalk. We have an ordinance and we need to challenge the administration to find a way to encourage people to clean their sidewalks when it snows.

Chairperson Trujillo will discuss this with Mr. Matt O'Riley in Land Use to see what can be done.

Councilor Rivera stated that there has been an exchange of phone calls from the Zozobra Committee. It is understood that they will reach out to Mr. Phelps to set up a meeting. Councilor Rivera would like to know what the recommendations are after these meetings. Mr. Phelps said that he would be meeting with them on Thursday and he will prepare a brief of that conversation and provide the Chair and committee with this information.

Chair Trujillo graciously extended his personal thanks to the Chief of Police, Chief of Fire Department, all of the Deputy Chiefs, Alfred Walker, Staff, Michelle – staff to the Police Department, Fran Lucero, Stenographer and to the committee members. Thank you for all of your hard work. Mr. Mizrahi echoed this sentiment.

Request to fund a 10 person Wildland Hand Crew from reimbursements.

The City of Santa Fe Fire Department lost grant funding from the New Mexico Youth Conservation Corps. This program funded individuals who we trained to function as seasonal wildland firefighters and to work on fuels reduction projects within the City while bolstering our own wildland response.

- They responded statewide through the NM Resource Mobilization Plan
- They responded to wildland and WUI incidents throughout the City of Santa Fe
 - They worked on the fuel reduction project in the Santa Fe River corridor
 - They removed multiple "hazardous trees" when specifically requested
 - Worked with USFS on the thinning and burning project within the SF Watershed

In an effort to keep our current response capabilities we are requesting the following:

- Ability to hire 10 seasonal temporary employees for 6 months.
 - Two Lead Forestry Technicians with benefits and eight Forestry Technicians without benefits. The total personnel cost for the 6 months is \$156,802.00.

These positions would be paid from the reimbursements obtained through a JPA while responding to Wildland fires throughout the season. Our average annual wildand fire reimbursement revenue for the last 3 years has been \$207,619.33.

As before this crew will be able to work on the Wildland Urban Interface (WUI) areas in and around Santa Fe; perform training and public education functions; do WUI assessments for homeowners, neighborhoods, and homeowners associations; do the landscaping and mitigation around city property; help with the watershed management plan and burning; and promote interagency cooperation with New Mexico State Forestry, Santa Fe County Fire Department and US Forest Service. All of these activities will set the framework for the crew as it develops and help to prove the worth of the program to the citizens of Santa Fe from the onset.

For decades we operated under the assumption that the wildland problem was the Forest Service's problem to deal with. We realize that we are the first response when there is wildfire in our community and we want to ensure we are well prepared for wildfire disaster.

2013 Requests

We would like to request the following:

- 1. Funding to continue to strengthen and develop the SFFD 10 person hand crew
- 2. Re-define "Lead" positions for hand crew

 -2 Lead positions will be seasonal with benefits to make the positions competitive with US Forest Service seasonal positions
 -Eight positions will be seasonal without benefits

- 3. Renew and expand the JPA with USFS We are in the process of completing the renewal of our JPA with the USFS to ensure reimbursement for firefighting and mitigation activities.
- 4. Start working with home and land owners on private property to decrease fire risk to the community We have created a form to help us work on hazardous fuel reduction with home and land owners within our jurisdiction. The ability to do these projects will greatly improve our ability to affect risk reduction in and around the City of Santa Fe.
