Award of Bid #14/33/B for Liquid Sodium Permanganate

BACKGROUND AND SUMMARY

On May 15, 2014 the City of Santa Fe Purchasing Office and the Water Division opened bids for Liquid Sodium Permanganate for FY 2014/15. The bid will allow the Water Division to purchase the chemical on a cost per pound and will be utilized for the production of treated water at the Water Treatment Facility. The bidders are as follows:

F2 Industries LLC, Smyma, TN awarded the bid for this chemical.

Partial funding in the amount of \$11,000.00 is available in business unit/line item 52361.530200 (Operating Supplies) for FY 2014/15. Partial funding is recommended for the Canyon Road Water Treatment Plant due to extremely low reservoir capacity and full allocation is no possible. Also, the dam intake rehabilitation project will start August 2014 through May 2015 which will limit the production at the Canyon Road Water Treatment Plant as well.
