**A RESOLUTION**

**APPROVING THE CITY OF SANTA FE’S PARTICIPATION IN A TRANSPORTATION FUND PROGRAM ADMINISTERED BY THE NEW MEXICO DEPARTMENT OF TRANSPORTATION FOR IMPROVEMENTS TO THE AGUA FRIA/SOUTH MEADOWS INTERSECTION.**

**WHEREAS**, the City of Santa Fe (“City”) and the New Mexico Department of Transportation (“NMDOT”) entered into a grant agreement under the Transportation Fund Program (“TPF”) for improvements to the Agua Fria/South Meadows intersection; and

**WHEREAS**, the total cost of the project is \$1,700,000 to be funded in proportional share by the parties as follows:

1. NMDOT’s share shall be ninety-five percent or \$1,615,000; and
2. The City’s proportional matching share shall be five percent or \$85,000; and

**WHEREAS**, the City shall pay all costs that exceed the total budgeted amount of \$1,700,000, to the extent permitted under law.

**NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**

1 CITY OF SANTA FE that Governing Body hereby approves a cooperative agreement for Project  
2 Control Number LP50019 with the NMDOT for the TPF Program for year 2022 for improvements  
3 to the Agua Fria Street/South Meadows Road intersection including five-foot wide bicycle lanes,  
4 six-foot wide sidewalks, turn lanes, and driveways within the control of the City.

5 **BE IT FURTHER RESOLVED** that this project maintains priority status for the City.

6 **BE IT FURTHER RESOLVED** that the cooperative agreement terminates on June 30,  
7 2025 and the City incorporates all the agreements, covenants, and understandings between the  
8 parties concerning the subject matter and that all such agreements, covenants, and understandings  
9 have been merged into the written agreement.

10 PASSED, APPROVED, and ADOPTED this 10<sup>th</sup> day of November, 2021.


