CITY OF SANTA FE MUNICIPAL CHARTER AMENDMENTS NOVEMBER 6, 2018 GENERAL ELECTION

At the General Election on Tuesday, November 6, 2018, the qualified electors of the City of Santa Fe will be asked to vote on the following question:

MUNICIPAL QUESTION CITY OF SANTA FE MUNICIPAL CHARTER AMENDMENTS

Shall the Santa Fe Municipal Charter be amended to allow the City to enact by ordinance its election date and the date on which officials take office as provided in the Local Election Act?

This change would amend Section 4.01(A) Election Date; Section 5.03 Mayor Term; Section 6.05 Councilor Term; Section 7.04 Municipal Judge Term; and Section 11.01 Transition.

FOR AMENDMENTS
AGAINST AMENDMENTS

Summary:

- The changes to Article IV will remove reference to the date of the regular city election and establish that the date of the election will be set by ordinance.
- The changes to Articles V, VI and VII will remove references to the date elected officials take office.
- The change to Article XI will add a subsection to change the ending date of elected officials' terms pursuant to the Local Election Act.

If the Charter Amendment Question is approved, ALL of the following changes will be made to the Charter:

(1) Article IV, Section 4.01(A) shall read as follows:

4.01 Elections.

A. Regular elections.

Regular city elections shall be held [on the first Tuesday in March of each even-numbered year] as provided by law.

(2) Article V, Section 5.03 shall read as follows:

5.03. Term of office.

The mayor shall be elected for a term of four years [, which shall begin on the sixth day after the election and continue until a successor has been duly elected and has taken office].

(3) Article VI, Section 6.05 shall read as follows:

6.05. Term of office.

Councilors shall be elected for a term of four years [, which shall begin on the sixth day after the election and continue until a successor has been duly elected and has taken office]. The terms of office of the two councilors from each district shall be staggered so that one councilor shall be elected from each district at each regular municipal election.

(4) Article VII, Section 7.04 shall read as follows:

7.04. Term of office.

The municipal judge shall be elected for a four-year term [, which shall begin on the sixth day after the election and continue until a successor has been duly elected and has taken office].

(5) Article XI, Section 11.01 shall read as follows:

11.01. Transition.

- **A.** Elected officials. City officials who are incumbent on the effective date of this Charter shall serve out their elected terms unless recalled under the provisions of this Charter.
- **B.** Appointed officials. All incumbent appointed officials and commissioners shall serve out their appointed terms unless removed in accordance with city ordinances, resolutions or state law.
- C. <u>City officials shall serve their elected terms pursuant to this Charter unless the ending date of their term is changed pursuant to the Local Election Act.</u>

Effective Date: If the Charter Amendment Question is approved by the voters, the changes will be effective at the time the results are certified by the proper canvassing board.
