18	WHEREAS, the City of Santa Fe ("City") and the New Mexico Department of
19	Transportation ("NMDOT") entered into an Agreement, Contract No. D18363, on October 18,
20	2019 ("Contract"), for \$151,185 to plan, design, and construct the intersection improvements at
21	Agua Fria-South Meadows (the "Project"); and
22	WHEREAS, the Governing Body amended the Contract's original termination date of
23	June 30, 2021, to June 30, 2022, via Resolution 2021-24; and
24	WHEREAS, the Governing Body approved a second amendment for term extension to
25	December 21, 2022, via Pacalutian 2022, 28; and

1	WHEREAS, a third amendment is needed to extend the Contract's termination date to June
2	30, 2024, to complete this project; and
3	WHEREAS, moving forward with constructing the Project remains a priority for the City to
4	alleviate traffic delays and improve safety at this intersection; and
5	WHEREAS, with the extension of the Contract, the Project is fully funded for construction.
6	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
7	CITY OF SANTA FE that the Governing Body supports extending the term of the Contract to June
8	30, 2024.
9	BE IT FURTHER RESOLVED that the City of Santa Fe accepts responsibility for the
10	Project; assumes the lead role in design development and construction of the Project; agrees to the
11	terms, conditions, and certification and reporting requirements of the Contract; and assumes ownership,
12	liability, and maintenance responsibilities for all amenities related to the completion of the Project.
