A RESOLUTION

REQUESTING APPROVAL OF AMENDMENT NO. 2 TO A MUNICIPAL ARTERIAL PROGRAM COOPERATIVE GRANT CONTRACT WITH THE NEW MEXICO DEPARTMENT OF TRANSPORTATION IDENTIFIED AS CONTROL NUMBER L500429 GRANTING A TIME EXTENSION FOR THE PLANNING, DESIGN, AND CONSTRUCTION OF AGUA FRIA STREET AND SOUTH MEADOWS ROAD INTERSECTION IMPROVEMENTS.

WHEREAS, the City of Santa Fe (“City”) and the New Mexico Department of Transportation (“NMDOT”) entered into an Agreement, identified as Control No. L500429 on November 10, 2020, for \$216,000 (“Contract”) to plan, design and construct the intersection improvements at Agua Fria-South Meadows; and

WHEREAS, the Governing Body amended the Contract’s original termination date of June 30, 2022, to June 30, 2023, via Resolution 2022-26;

WHEREAS, a second amendment is necessary to extend the Contract to June 30, 2024 to construct this project;

1 **WHEREAS**, moving forward with constructing this project remains a priority for the City to
2 alleviate traffic delays and improve safety at this intersection; and

3 **WHEREAS**, this project is fully funded through construction.

4 **NOW THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
5 **CITY OF SANTA FE** that the Governing Body supports extending the term of this Contract to June
6 30, 2024.

7 **AND BE IT FURTHER RESOLVED** that the City of Santa Fe accepts responsibility for the
8 Project; assumes the lead role in design development and construction of the Project; agrees to the
9 terms, conditions, and certification and reporting requirements of the Contract; and assumes ownership,
10 liability, and maintenance responsibilities for all amenities related to the completion of the Project.


