12	PROGRAM COOPERATIVE GRANT CONTRACT WITH THE NEW MEXICO

14	GRANTING A TIME EXTENSION FOR THE PLANNING, DESIGN, AND CONSTRUCTION

20	November 10, 2020, for \$216,000 ("Contract") to plan, design and construct the intersection
21	improvements at Agua Fria-South Meadows; and
22	WHEREAS, the Governing Body amended the Contract's original termination date of
23	June 30, 2022, to June 30, 2023, via Resolution 2022-26;
24	WHEREAS, a second amendment is necessary to extend the Contract to June 30, 2024 to
25	construct this project:

6	30, 2024.

9	terms, conditions, and certification and reporting requirements of the Contract; and assumes ownership,
10	liability, and maintenance responsibilities for all amenities related to the completion of the Project.
