10 **A RESOLUTION**

11 **REQUESTING APPROVAL OF AMENDMENT NO. 1 TO A MUNICIPAL ARTERIAL**
12 **PROGRAM COOPERATIVE GRANT CONTRACT WITH THE NEW MEXICO**
13 **DEPARTMENT OF TRANSPORTATION IDENTIFIED AS CONTROL NUMBER L500473**
14 **GRANTING A TIME EXTENSION FOR THE PLANNING, DESIGN, AND**
15 **CONSTRUCTION OF AGUA FRIA STREET AND SOUTH MEADOWS ROAD**
16 **INTERSECTION IMPROVEMENTS.**

18 **WHEREAS**, the City of Santa Fe (“City”) and the New Mexico Department of
19 Transportation (“NMDOT”) entered into an Agreement, Contract No. D18964, identified as
20 Control No. L500473 on September 8, 2021 (“Contract”, for \$124,444 to plan, design and
21 construct the intersection improvements at Agua Fria-South Meadows (the “Project”) via
22 Resolution 2021-45; and

23 **WHEREAS**, the Contract’s original termination date was June 30, 2023; and

24 **WHEREAS**, this Resolution amends the Contract to extend the agreement until June 30,
25 2024, to construct this Project; and

1 **WHEREAS**, moving forward with this Project remains a priority for the City to alleviate
2 traffic delays and improve safety at this intersection; and

3 **WHEREAS**, this Project is fully funded through construction.

4 **NOW THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
5 **CITY OF SANTA FE** that the Governing Body supports extending the term of this Contract to June
6 30, 2024.

7 **AND BE IT FURTHER RESOLVED** that the City of Santa Fe accepts responsibility for
8 the Project; assumes the lead role in design development and construction of the Project; agrees to the
9 terms, conditions, and certification and reporting requirements of the Contract; and assumes
10 ownership, liability, and maintenance responsibilities for all amenities related to the completion of the
11 Project.
