**A RESOLUTION**

**REQUESTING APPROVAL OF SECOND AMENDMENT TO A LOCAL GOVERNMENT TRANSPORTATION PROJECT FUND GRANT FROM THE NEW MEXICO DEPARTMENT OF TRANSPORTATION IDENTIFIED AS CONTROL NUMBER LP50008 GRANTING A TIME EXTENSION FOR THE PLANNING, DESIGN, AND PAVEMENT REHABILITATION OF GUADALUPE BRIDGE.**

**WHEREAS**, the City of Santa Fe (“City”) and the New Mexico Department of Transportation (“NMDOT”) have entered into an Agreement under the Local Government Transportation Project Fund, Contract No. D18451, Control No. LP50008 (“Contract”) on March 18, 2020; and

**WHEREAS**, Section 19 allows for modification of the Contract by an instrument in writing executed by the parties; and

**WHEREAS**, the City and NMDOT wish to extend the term of the Contract for a second time to allow for Project completion; and

1           **WHEREAS**, both parties wish to agree to modify this Contract.

2           **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
3 **CITY OF SANTA FE** that the Governing Body extends the completion dates of the Local  
4 Government Road Transportation Fund Agreement from NMDOT to June 30, 2024.

5           **BE IT FURTHER RESOLVED** that the City of Santa Fe accepts responsibility for the  
6 Project; assumes the lead role in design development and construction of the Project; agrees to  
7 the terms, conditions, and certification and reporting requirements of the Contract; and assumes  
8 ownership, liability, and maintenance responsibilities for all amenities related to the completion  
9 of the Project.


