

8	DWELLING UNITS PER ACRE) TO C-1 (OFFICE AND RELATED COMMERCIAL);

11	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:		
12	Section 1. The following real property (the "Property"), located within the municipal		
13	boundaries of the city of Santa Fe, which was formerly restricted to and classified as R-21		
14	(Residential twenty-one (21) dwelling units per acre), is hereby restricted to and reclassified as C-		
15	1 (Office and Related Commercial): A parcel of approximately 0.13 acres located at 1309 South		
16	St. Francis Drive, more particularly described in Attachment A, attached hereto and incorporated		
17	by reference. In Attachment A, the parcel is described as a tract of land lying within N.E. 1.4		
18	Section 35, Township 17 North, Range 9 East New Mexico Prime Meridian, recorded in Plat Book		
19	498, Page 004 of the Office of the County Clerk.		
20	Section 2. The official zoning map of the city of Santa Fe adopted by Ordinance No.		
21	2001-27 is hereby amended to conform to the change of zoning classification for the Property set		
22	forth in Section 1 of this Ordinance.		
23	Section 3. Pursuant to SFCC 1987, Section 2-2.4, this Ordinance shall be published		
24	by title and general summary and shall become effective five (5) days after publication.
