15	that has rented the City of Santa Fe's ("City's") Fort Marcy Ballpark for summer baseball games		
16	since 2012; and		
17	WHEREAS, every year since 2012, the League has submitted Special Dispenser Permit		
18	applications for each of its home games, individually; and		
19	WHEREAS, obtaining Special Dispenser Permits is both time consuming and expensive;		
20	and		
21	WHEREAS, the League relies on the money from beer and wine sales at its games for its		
22	operations; and		
23	WHEREAS, the League brings family-friendly events to the city and has brought our		
24	community together to support the Santa Fe Fuego baseball team; and		
25	WHEREAS, it is in the City's interest that the League continues to use Fort Marcy

Baseball Park; and

2 WHEREAS, the League operates Governmental Liquor Licenses in other cities such as
3 Roswell, New Mexico; and

WHEREAS, the League has requested that the City acquire a Governmental Liquor
License from the New Mexico Regulation and Licensing Alcoholic Beverage Control Division via
the City Clerk's Office, and that it lease the license to the League for use during baseball games at
Fort Marcy Ballpark during the League summer baseball season; and

8 WHEREAS, there are many local vendors that could benefit from sales of their products
9 by the lessee of the City's Governmental Liquor License; and

WHEREAS, on August 30th, 2023, the Governing Body approved a Liquor Hearing
Officer's recommendation to approve the request from the City for a Governmental Liquor License
with on-premises consumption and patio service, to be located at Fort Marcy Park, 490 Bishops
Lodge Road ("License"); and

WHEREAS, a governmental liquor license requires an authorized representative.

NOW, THEREFORE, BE IT RESOLVED THAT THE GOVERNING BODY OF
 THE CITY OF SANTA FE recognizes the Office of the City Manager as its representative for
 the License.

BE IT FURTHER RESOLVED that the Governing Body strongly encourages the League
 to consider using the services of local Santa Fe businesses for all matters related to beer and wine
 distribution and sales.

- BE IT FURTHER RESOLVED the City Manager shall ensure that the following
 directives are strictly adhered to, for the purpose of ensuring a safe environment for Fort Marcy
 Ballpark attendees and for surrounding neighborhoods:

2	consumption to a maximum of three alcoholic beverages during the course of a		
3	permitted event or a professional baseball game.		
4	3. As required by SFCC 1987, 26-6.3(B)(2), the sale of alcohol shall cease at least 30		
5	minutes before the end of the permitted event or at the end of sixth inning for		
6	professional baseball games.
