21	"election proclamation" referred to in Section 4.03(C) of the Santa Fe Municipal Charter; and
22	WHEREAS, the same Subsection of the Election Code requires the City to deliver the
23	resolution to the Santa Fe County Clerk, pursuant to NMSA 1978, Section 1-22-4(A).

7	E. One City Councilor from District 4 for a four-year term.

9	Resolution to the Santa Fe County Clerk, as the notice required pursuant to NMSA 1978, Section 1-
10	22-4(A), on or before July 7, 2025.
