**A RESOLUTION**

**AUTHORIZING THE SALE AND CONSUMPTION OF BEER AND WINE DURING THE  
RAILYARD PLAZA SUMMER SCENE CONCERTS SPONSORED BY THE  
INTERNATIONAL FOLK ART MARKET ON JULY 9, 10, AND 11, 2025, PURSUANT  
TO SUBSECTION 23-6.2(C) SFCC 1987.**

**WHEREAS**, SFCC 1987, Section 23-6.2 governs the consumption of alcohol on City  
property; and

**WHEREAS**, for serving alcohol at City properties not specifically mentioned in SFCC  
1987, Section 23-6.2(A), the ordinance requires the Governing Body to approve a resolution that  
specifies the event, date, hours, location, number of expected attendees, type of alcohol to be  
served, permits, and insurance, at least thirty (30) days prior to the event; and

**WHEREAS**, the Railyard Plaza Summer Scene Concert event series has taken place  
annually for sixteen (16) years; and

**WHEREAS**, the Railyard Plaza Summer Scene Concerts on July 9,10, and 11, 2025, will  
be sponsored by the International Folk Art Market (“IFAM”); and

**WHEREAS**, IFAM is the world’s largest folk art market and it has taken place in Santa

1 Fe every July since 2004, bringing together over one hundred (100) artists from nearly sixty (60)  
2 different countries; and

3 **WHEREAS**, IFAM intends to work with “As Above, So Below”, a local distillery, to serve  
4 beer and wine for the event, promoting a local business to the community.

5 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
6 **CITY OF SANTA FE** that alcohol service during the Railyard Plaza Summer Scene Concerts  
7 sponsored by IFAM, is hereby approved according to the following parameters:

8 Event: Railyard Plaza Summer Scene Concerts

9 Sponsored by IFAM

10 Dates: July 9, 2025; July 10, 2025; and July 11, 2025

11 Hours: 6:30 p.m. to 9:30 p.m.

12 Location: Railyard Plaza

13 Number of expected attendees: 500 to 1,000, per event


14 Type of alcohol to be served: Beer and wine


15 Required Permits: Public Celebration Permit

16 Required Insurance: Liquor Liability and General Liability insurance  
17 with limits not less than \$2,000,000, per  
18 occurrence and in aggregate, with the City of  
19 Santa Fe, its officials, directors, employees, and  
20 agents as additional insureds on a primary and  
21 noncontributory basis. As Above, So Below  
22 Distillery shall provide the City with Certificates  
23 of Insurance and applicable endorsements  
24 evidencing such coverage.
