16	WHEREAS, SFCC 1987, Section 23-6.2 governs the consumption of alcohol on City
17	Property; and
18	WHEREAS, in instances of serving alcohol on City properties not specifically mentioned
19	in SFCC 1987, Section 23-6.2(A), the ordinance requires the Governing Body to approve a
20	resolution that specifies the event, date, hours, location, number of expected attendees, type or
21	alcohol to be served, required permits, and insurance, at least thirty (30) days prior to the event
22	and
23	WHEREAS, SFCC 1987, Section 23-6.3(3)(a), requires that the alcohol provider obtain
24	the required permit(s), which shall be approved by the state of New Mexico and the City of Santa
25	Fe; and

WHEREAS, Resolutions 2025-16 and 2025-23 each authorized the sale and consumption
of alcohol in the Railyard—Resolution 2025-16 in the Railyard Park for the Movies in the Park
event series and Resolution 2025-25 in the Railyard Plaza for the Summer Scene Concerts event
series; and
WHEREAS, the required permit listed in Resolution 2025-16 and in 2025-23 is a Special
Dispenser Permit; and
WHEREAS, a Public Celebration Permit is required for both the Railyard Movies in the
Park and the Railyard Plaza Summer Scene Concerts event series.
NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
CITY OF SANTA FE that the required permit for the events approved for serving alcohol in
Resolution 2025-16 and 2025-23, respectively, shall be a Public Celebration Permit rather than a
Special Dispenser Permit.
