19	specifies the event, date, hours, location, number of expected attendees, type of alcohol to be
20	served, permits, and insurance, at least thirty (30) days prior to the event; and
21	WHEREAS, Pride is an annual, global celebration of the lesbian, gay, bisexual,
22	transgender, and queer (LGBTQ+) community, that is held in June every year; and
23	WHEREAS, 2025 will mark Santa Fe's thirty-second year participating in the annual Pride
24	celebration; and
25	WHEREAS, in 2024, over eleven thousand (11,000) people participated in the Santa Fe
