18	1987, Section 23-6.2(A), the ordinance requires the Governing Body to approve a resolution that
19	specifies the event, date, hours, location, number of expected attendees, type of alcohol to be
20	served, permits, and insurance, at least thirty (30) days prior to the event; and
21	WHEREAS, the Railyard Plaza Summer Scene Concert event series has taken place
22	annually for sixteen (16) years; and
23	WHEREAS, the Railyard Plaza Summer Scene Concert on August 15, 2025, will be
24	sponsored by IndigenousWays; and
25	WHEREAS, Indigenous Ways is a Native-led Indigenous Arts nonprofit that highlights

1 indigenous artists of all media; and 2 WHEREAS, since 2007, Indigenous Ways has offered educational programs, including 3 artistic and musical performances, as well as initiatives aimed at promoting cultural awareness, 4 values, and traditions; and 5 WHEREAS, Indigenous Ways intends to work with "As Above, So Below", a local 6 distillery, to serve beer and wine for the event, promoting a local business to the community. 7 NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE 8 CITY OF SANTA FE that alcohol service during the Railyard Plaza Summer Scene Concert 9 sponsored by Indigenous Ways, is hereby approved according to the following parameters: 10 Event: Railyard Plaza Summer 11 Sponsored by Indigenous Ways 12 August 15, 2025 Dates: 13 Hours: 6:30 p.m. to 9:30 p.m. 14 Location: Railyard Plaza 15 Number of expected attendees: 500 to 1,000 16 Type of alcohol to be served: Beer and Wine 17 Required Permits: **Public Celebration Permit** 18 Required Insurance: Liquor Liability and General Liability insurance 19 with limits not less than \$2,000,000, per 20 occurrence and in aggregate, with the City of 21 Santa Fe, its officials, directors, employees, and 22 agents as additional insureds on a primary and 23 noncontributory basis.
