adopted Resolution No. 2016-78, which amended the Master Plan, to establish alternative height and setback standards for the residential six dwelling units per acre and residential twelve dwelling units per acre residentially zoned districts for Estancias de Las Soleras and Ross's Peak developments; and

WHEREAS, on September 12, 2018, the Governing Body approved Case No. 2018-50 and adopted Resolution No. 2018-59, which approved Amendment No. 3 to the Master Plan, which changed the zoning from mixed use to residential, twenty-one dwelling units per acre, for property located between Governor Miles, Interstate 25 and Cerrillos Road and Richards Avenue, reduced the 90-foot utility and trail corridor to 45 feet on the North Side of Beckner Road; and

WHEREAS, on May 31, 2023, the Governing Body approved Case No. 2021-3811 and adopted Resolution No. 2023-27, which approved Amendment No. 4 to the Las Soleras Master Plan, which increased the density from six units per acre to ten units per acre for land located at 4601 Rail Runner Road; and

WHEREAS, Orion-West, agent for Beckner Road Partnership, LLC ("Applicant"), applied to amend the Las Soleras Master Plan for approximately 41.44 acres of land, known as Tracts 19, 20, 23, 24 and 26, and identified in Attachment A (the "Property"), from Mixed Use (MU), Business Industrial Park (BIP), and General Office (C-1) to General Commercial (C-2) and to reduce the width of the Utility and Trail Corridor (La Rambla Trail) from 90 feet to 45 feet south of Beckner Road ("Proposed Amendment"); and

WHEREAS, amending the Master Plan requires an early neighborhood notification ("ENN") meeting and Applicant held an ENN on November 14, 2023; and

WHEREAS, SFCC 1987, Section 14-3.9(D)(1) requires the following findings for an amendment of a master plan:

- (a) The master plan is consistent with the general plan;
- (b) The master plan is consistent with the purpose and intent of the zoning districts that apply to or will apply to the master plan area and with the applicable use regulations and
