A RESOLUTION

AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOL DURING THE REDS AND GREENS TRUE BLUESFEST ON OCTOBER 21, 2023, AT FORT MARCY PARK, PURSUANT TO SFCC 1987, SECTION 23-6.2(C).

WHEREAS, SFCC 1978, Section 23-6.2 governs the consumption of alcohol on City property; and

WHEREAS, for service of alcohol at events located in locations not specifically mentioned in SFCC 1987, Section 23-6.2(A), the Governing Body must approve a resolution that specifies the event, date, hours, location, number of expected attendees, type of alcohol to be served, permits, and insurance, at least thirty days prior to the event; and

WHEREAS, the Reds and Greens True Bluesfest is a new event for the City of Santa Fe; and

WHEREAS, the Governing Body believes in supporting events at which community members can gather to enjoy music; and

WHEREAS, the Governing Body supports that beer and wine be served at the Reds and

1 Greens True Bluesfest to augment enjoyment of the festival; and

2 **WHEREAS**, the Reds and Greens True Bluesfest organizers have planned the festival to
3 occur at Fort Marcy Park.

4 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
5 **CITY OF SANTA FE** that alcohol service during the Reds and Greens True Bluesfest is hereby
6 approved according to the following parameters:

7 Event: Reds and Greens True Bluesfest.

8 Date: October 21, 2023.

9 Hours: From 12:00 pm. to 4:30 p.m. on Saturday, October 21, 2023.

10 Location: Fort Marcy Park.

11 Number of expected attendees: 1,000 tickets for the festival will be available.

12 Type of alcohol to be served: Beer and wine.

13 Required permits: Special dispenser permit.

14 Required insurance: Liquor liability insurance in the amount of \$1,000,000.00.
