Specifications:

The City of Santa Fe is seeking bids for the Erosion Control and Bank Repair at Arroyo de Los Chamisos North Fork – Site 1 and Site 2. Site 1 consists of erosion control and repair near the intersection of Alamosa Drive and Santa Clara Drive. Site improvements include a new wire enclosed riprap swale and rundown, gabion walls, and a minor diversion berm.

Site 2 includes repair or removal and replacement of the gabion walls, concrete wing walls, and the existing plunge basin / energy dissipator which have failed due to previous runoff events.
