II. QUESTIONS AND CLARIFICATIONS:

- 1. Can you please confirm the correct bid date for the Guadalupe Street Reconstruction project? The advertisement that was posted in the Albuquerque Journal listed a date of November 21, 2022, at 9:00 am. After reviewing the documents, the dates listed within are November 22, at 3:00 pm. Can you verify which date is the correct bid due date?
 - a. The original Advertisement was corrected from November 21st to November 22nd, 2022 at 3:00 PM. However, the bid opening date has been postponed to December 6th, 2022.

- 2. Due to the City's Electronic Plan Room being down causing a delay on the ability to procure the bidding documents, the complexity of the project, and due to the bid day during Thanksgiving week, would the City be willing to move the bid date to December 6th? We have found that projects that bid during a holiday week have less subcontractor and supplier participation and it also decreases the ability to resolve questions or unclear aspects about the supplier and subcontractor quotes. The delay in the ability to procure the documents also limited the contractors time to review and prepare for the projects bid submission.
 - a. Bid opening date has been moved to December 6th, 2022 at 3:00 PM.
- 3. Is there a maximum size email the City of Santa Fe can receive? If the bid needs to be sent via multiple emails, do all need to be submitted before 3:00 PM or just the first?
 - a. All documents have to be received by the 3:00 PM deadline or the bid will be deemed non-responsive.

BID GUARANTEE: Each bid shall be accompanied by an acceptable form of Bid Guarantee in an amount equal to at least five percent (5%) of the amount of the bid payable to the City of Santa Fe as a guarantee that if the bid is accepted, the Bidder will execute the Contract and file acceptable Performance and Labor and Material Payment Bonds within ten (10) days after the award of Contract.

The Bid shall also include a signed "Certificate of Bidder Regarding Equal Employment Opportunity", "Certificate of Non-Segregated Facilities", a signed "Non-Collusion Affidavit of Prime Bidder", "Subcontractor Listing", and "Acknowledgement for Receipt of Addenda". OWNERS RIGHTS RESERVED: The City of Santa Fe, herein called the City, reserves the right to reject any or all bids and to waive any formality or technicality in any bid in the best interest of the City.

NON-MANDATORY PRE-BID CONFERENCE: A non-mandatory pre-bid conference will be held for this project on <u>November 9th, 2022</u>, at 1:30 PM, at the Railyard Park Community Room, 740 Cerrillos Road, Santa Fe, NM 87505.

CONTRACT TIME: Contract will be 365 Calendar Days to Substantial Completion, 395 Calendar Days to Final Completion (30 Calendar Days from Substantial Completion to Final Completion).

The work to be performed with this project consist of furnishing all equipment, labor, and materials for the construction of the Guadalupe Street Reconstruction in accordance with the drawings, specifications, and other Contract Documents.

The project is subject to New Mexico Department of Workforce Solutions, Public Works Bureau (formerly NM Dept. of Labor, Labor and Industrial Division) Wage Rate Decision No. SF-22-2574-A.
