In 2021, the SFSWMA's Joint Powers Board approved the purchase of the Morbark 3400XT Wood Hog Grinder for the mulching operation at the Buckman Road Recycling and Transfer Station (BuRRT) (Sourcewell Contract No. 050119-MBI). Due to Morbark's proprietary knowledge of the machine, the primary focus of this sole source is to obtain:

- Morbark specific parts,
- Technical support,
- Diagnostics, and
- Repairs.

Morbark specific parts and support are procured on an as needed basis for the equipment.

In 2021, the SFSWMA's Joint Powers Board approved the purchase of the Morbark 3400XT Wood Hog Grinder for the mulching operation at the Buckman Road Recycling and Transfer Station (BuRRT) under Sourcewell Contract No. 050119-MBI. Morbark has proprietary knowledge and manufacturing techniques for Morbark specific parts. The majority of parts used to maintain the equipment are equipment specific. Also, by consulting directly with Morbark, the SFSWMA gains access to the extensive knowledge and technical support for the specified equipment. There are no other manufacturers of proprietary parts. Therefore, the use of Morbark for parts, technical support, diagnostics and repairs will minimize the costs of maintenance and repair over the next four years. There are no vendors or manufacturers in New Mexico that can provide the necessary Morbark parts, technical support, diagnostics and repairs for the Morbark 3400XT wood hog grinder at BuRRT.
