#### **ACTION**

Request Approval of Sole Source Request and Determination for Conduent State and Local Solutions Inc.

#### **BACKGROUND AND SUMMARY:**

On August 9, 2017, Governing Body approved a three-year contract with Conduent State and Local Solutions, Inc. to provide the Parking Division with software and implementation services for a Parking Citation Administration and Revenue Reconciliation System. This is an integrated system that supports all aspects of parking citations including appeals, past due collections, issuance, payment and documentation. Amendment 1 extended the term of the original agreement to August 31, 2022.

Due to the essential nature of the equipment, software and business processes surrounding this vendors services, Parking Division is requesting procure/maintain the services of Conduent State and Local Solutions Inc. through Sole Source for the following reasons:

This contractor was selected by RFP and their hardware, software and business workflow has been implemented to manage parking violation citations including citations issuance, payment tracking, processing appeals, conducting investigations for appeals, recording appeal decisions, revenue accountability, detailed audit processes and records, tracking Hearing decisions, etc. The City requires continuation of all of these features to serve the parking public. The City's Parking has implemented major equipment, software and business processes around this vendor's products and services. Conversion would require at least one year to complete and additional budget.

The term of Professional Services Agreement with Conduent State and Local Solutions, Inc. will be for one year with a compensation not to exceed \$158,508.00 including NMGRT.

#### Scope of Services City of Santa Fe Parking:

Implement and manage a customized parking violation issuance and processing application, inclusive of: (1) Parking citation issuance based on Santa Fe's unique violation codes and citation field requirements and design; (2) Citation software (CitySight) integration with parking meter apps (ParkMobile) and permits, including an initial and "last chance" verification of compliance prior to citation issuance, and real-time database integration (eTIMS); (3) Manage violation processing through a web-based, hosted platform, including complex rules concerning the retrieval of name and address information through departments of motor vehicles, customized noticing (notice of violation, reminder notices, delinquency notices, referral notices) based on prescribed intervals, including penalty assessments and referrals; and citation aging and closure (payment, not liable decisions, etc.) (4) Permit processing configuration, including residential and guest permits, including special business rules; (5) Hearing processing, including walk-in and online disputes, correspondence and records retention, customized hearing queues and decision codes, and tailored hearing decisions; (6) Payment portals, cashiering integration, and payment tracking, including reconciliation; (7) Payment plans and forgiveness programs, including the financial hardship program and rules concerning fine reductions and accessibility; (8) Creation and provision of key reports; (9) IVR hosting and integration; (10) ongoing consultation concerning data science and beset practices.

#### **RE: Parking Enforcement Pricing**

Dear Ms. Serrano,

In response to our recent conversations, we are pleased to submit a Rough Order of Magnitude budgetary estimate (ROM) for the Parking enforcement program. Conduent will continue with the scope of work currently being provided to the City of Santa Fe under the terms and conditions of contract #17-0858. Conduent is proposing that we continue with our existing pricing model. The interface with the garage systems will need to be priced as a change order as we need some more details from the equipment vendor.

#### **Scope Overview**

<u>Program Database</u> – Conduent shall establish, maintain, and make available to the City an internet-based database of violations recorded by the Systems

<u>Violation Processing</u> - Conduent shall retrieve violation images from the Systems and process such violations according to business rules and a noticing cycle established and approved by the City and agreed to by Conduent.

<u>Online Payment Processing</u> – Conduent will maintain a credit card pay-by-web System for the program.

<u>Virtual Permit Fulfillment</u> – Conduent will maintain a parking permit portal for virtual permitting fulfillment.

- 2. Term: 1-year base term.

#### **Implementation**

There will be no implementation period for the services currently being provided to the City of Santa Fe.

The interface with the garage systems will need to be priced as a change order. Further details are required from the equiptment vendor inoder to to determain project scope.

This Rough Order of Magnitude quote is expressly conditioned upon Conduent and the City of Santa Fe reaching a mutual agreement on the terms and conditions of any applicable contract. This estimate is not a binding offer and must be memorialized in a mutually acceptable contract subject to the aforementioned terms and conditions.
