*Sole Source Request Justification Questions 1-3.

Due to several high priority airport projects, the division is requesting to issue a Sole Source contract with Molzen Corbin. The high priority projects include the completion of the Airport Terminal and Parking Lot Expansion, the FAA grant closeouts to Taxiway D (Grant 49) and Taxiway G (Grants 52/53), the completion of the ILS closeout for RSA 02 grading project (Grant 54) and the recent project of design/construction of the midfield emergency project where the pavement is starting to fail. There are two NMDOTAD grants in the midst of being accepted and once those are signed, design should be in place.

Projects are on-going and Molzen Corbin has to be on contract until work is completed. To possibly change vendors and the service interruptions to those projects could lead to the non-issuance of grants from either FAA or NMDOTAD as we are mandated to have A/E services when we accept the grants (Grant Assurance 32). The vendor is also security cleared with SAF airport security badges in order to oversee the projects.

3. Explain why other similar professional services, services, construction or item(s) of tangible personal property *cannot* meet the intended purpose of the contract.

Projects are on-going and Molzen Corbin has to be on contract until work is completed. To possibly change vendors and the service interruptions to those projects could lead to the non-issuance of grants from either FAA or NMDOTAD as we are mandated through the grant acceptance process to have A/E services under contract (Grant Assurance 32).

No other A/E firm would want to take the responsibility of errors and omissions created by a previous design firm.
