This purchase will be made utilizing State Homeland Security Grant Program (SHSGP) funding administered by the New Mexico Department of Homeland Security and Emergency Management (NM DHSEM), and has received approval by the City of Santa Fe Governing Body.

The City has invested heavily in upgrading its Law Enforcement Specialty Team capabilities in previous years, including other purchases made with SHSGP funding as approved by the Governing Body. The purchase of portable X-ray equipment is an essential upgrade undertaken by the Santa Fe Police Department's Emergency Ordinance Disposal (EOD) Team to maintain its FBI qualification and Type II status under the National Incident Management System (NIMS). X-ray capabilities are an invaluable tool for EOD to determine whether suspect packages pose a danger to the public.

The SmartRay system is designed for portability, and has a unique operating system which allows Explosive Ordinance Disposal Team members to utilize minimal X-Ray radiation to capture images of items they may be examining to determine whether a threat or hazard exists to the public. This device is appropriate in size and weight for easy transportation in current Emergency Ordinance Disposal Team vehicles. This device was specifically identified in the City's grant application, which has undergone thorough review and subsequent approval by the Governing Body, New Mexico Department of Homeland Security (NM DHSEM), and Federal Emergency Management Agency (FEMA).
