AMENDMENT No. 1 (the "Amendment") to the CITY OF SANTA FE PROFESSIONAL SERVICES AGREEMENT dated April 21, 2017 (the "Agreement"), between the City of Santa Fe (the "City") and Expert Fitness Group, LLC (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor whichever occurs last.

**RECITALS**

A. Under the terms of the Agreement, Contractor has agreed to provide professional instruction/training for classes, clinics and events.

B. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. COMPENSATION:

Article 3, of the Agreement is amended to increase the compensation by Five Thousand Dollars and No Cents (\$5,000.00), so that Article 3, A reads as follows:

A. The City shall pay to the Contractor in full payment for services rendered a sum not to exceed Ten Thousand Dollars and No Cents (\$10,000.00) inclusive of gross receipts taxes; at the current rate of 8.3125%. Payment shall be made for services actually rendered at a rate of sixty dollars (\$ 60.00) per hour, minimum 1 hour and then .5 increments thereafter plus a \$75.00 trip charge for each visit to GCCC

2. TERM:

Article 5 of the Agreement is hereby deleted. A new Article 5 of the Agreement is inserted to extend the term of the Agreement, so that Article 5 reads in its entirety as follows:

This Agreement shall be effective when signed by the City and the Contractor whichever occurs last and shall terminate on June 30, 2019 unless amended in writing to extend the term by one additional year, total term not to exceed four years, unless terminated sooner pursuant to Paragraph 6, below.

3. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.


