

**BUCKMAN DIRECT DIVERSION BOARD
AMENDMENT No. 1 TO
PROFESSIONAL SERVICES AGREEMENT
WITH SimplexGrinnell LP
#17-1179**

THIS AMENDMENT No. 1 (the "Amendment") to the PROFESSIONAL SERVICES AGREEMENT, dated October 25, 2017, and as subsequently amended (the "Agreement"), is made between the Buckman Direct Diversion Board ("BDDDB") and SimplexGrinnell LP ("Contractor"). The effective date of this Amendment shall be the date it is executed by the Facilities Manager.

RECITALS

A. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the Board and the Contractor agree as follows:

1. SCOPE OF SERVICES.

Article 1 is amended to add additional services; Contractor shall provide installation and parts for the BDDDB as follows:

- A. Replacement of existing GE 320ACC Smoke Detectors with new Gentex 8103 Smoke Detectors that are connected to the PLC.
- B. Provide two spare Gentex 8103 Smoke Detectors.
- C. In buildings that have an EST IO500 Fire Alarm Panel, contractor will replace the existing Smoke and Heat Detectors with new.
- D. Testing of new devices once installed.

2. COMPENSATION.

Article 3, paragraph A of the Agreement is amended to increase the amount of compensation by a total of Eight Thousand Four Hundred Forty-two and .14/100 Dollars (\$8,442.14) plus applicable gross receipts tax, so that Article 3, paragraph A reads in its entirety as follows:

A. The BDDDB shall pay to Contractor in full payment for services rendered, a sum not to exceed Fifteen Thousand Four Hundred Seven and .94/100 Dollars (\$15,407.94) plus applicable gross receipts tax.


3. AGREEMENT IN FULL FORCE.


