CITY OF SANTA FE AMENDMENT No. 1 TO PROFESSIONAL SERVICES AGREEMENT

AMENDMENT No. 1 (the "Amendment") to the CITY OF SANTA FE
PROFESSIONAL SERVICES AGREEMENT, dated September 7, 2017 (the
"Agreement"), between the City of Santa Fe (the "City") and Fire Safety Sales Co. (the
"Contractor"). The date of this Amendment shall be the date when it is executed by the
City and the Contractor whichever occurs last.

RECITALS:

- A. Under the terms of the Agreement, Contractor has agreed to provide professional services.
- B. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. SCOPE OF SERVICES

Article 1 of the Agreement is amended to add additional services, so that Article 1 reads as follows:

- A. Furnish the material and supply the labor necessary for the completion of troubleshooting and repairing equipment at the Mary Esther Gonzales Senior Center (1121 Alto Street, Santa Fe, New Mexico), Pasatiempo Senior Center (664 Alta Vista Street, Santa Fe, New Mexico) and Luisa Senior Center (1500 Luisa Street, Santa Fe, New Mexico).
- B. Furnish the material and supply the labor necessary for the completion of troubleshooting and repairing equipment at the Ventana De Vida Senior Center (1500

Pacheco, Santa Fe, New Mexico).

- C. Install three fuse links at Luisa Senior Center (1500 Luisa Street, Santa Fe, New Mexico).
 - D. Provide one Class K Buckeye 6 liter refill.
- E. Install two fuse links at Pasatiempo Senior Center (664 Alta Vista Street, Santa Fe, New Mexico).
- F. Provide and install one backflow preventer ¾ wilkins at the Mary Esther Gonzales Senior Center (1121 Alto Street, Santa Fe, New Mexico).
- G. Provide and install two 200 psi water gauge at the Mary Esther Gonzales Senior Center (1121 Alto Street, Santa Fe, New Mexico).
- H. Provide and install one rangeguard 4 gallon tank, one ansul tank three gallon and one LT-20R nitrogen cartridge at the Mary Esther Gonzales Senior Center (1121 Alto Street, Santa Fe, New Mexico).

2. <u>COMPENSATION.</u>

Article 3, paragraph A of the Agreement is amended to increase the amount of compensation by a total of three thousand twenty four dollars (\$3,324.00) so that Article 3, paragraph A reads in its entirety as follows:

A. The City shall pay to the Contractor in full payment for services rendered, a sum not to exceed four thousand seven hundred twenty four dollars (\$4,724.00), plus applicable gross receipts taxes.

AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and

shall remain in full force and effect, in accordance with its terms.
