AMENDMENT NO. 3 TO THE

PROFESSIONAL SERVICES AGREEMENT ITEM#16-0812

AMENDMENT NO. 3 (the "Amendment") to the CITY OF SANTA FE PROFESSIONAL SERVICES AGREEMENT, dated August 29, 2016, between the City of Santa Fe (the "City") and New Mexico Pest Control (hereinafter "Contractor"). The date of this Amendment shall be the date when it is executed by the City or the Contractor, whichever occurs last.

RECITALS

- A. Under the terms of the Agreement, Contractor has agreed to provide monthly pest control green services for the City at Marty Sanchez Links de Santa Fe (MSL) located at 205 Caja del Rio, Santa Fe, NM 87505, Genoveva Chavez Community Center (GCCC) located at 3221 Rodeo Road, Santa Fe, NM 87507 and Salvador Perez Pool and Fitness Facility located at 601 Alta Vista, Santa Fe, NM 87505.
- B. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. <u>COMPENSATION</u>

Article 3, paragraph A of the Agreement is amended to increase the amount of compensation by a total of six thousand five hundred dollars (\$6,500), so that Article 3, paragraph A reads in its entirety as follows:

A. The City shall pay to the Contractor in full payment for services rendered, a sum not to exceed seventeen thousand dollars (\$17,000.00), plus applicable gross receipts taxes.

2. <u>TERM AND EFFECTIVE DATE:</u>

Article 5 of the Agreement, is amended to extend the term of the agreement, so that Article 5 reads in its entirety as follows:

The Contractor is granted an option to renew this Agreement for an additional one (1) year term, to terminate on June 30, 2019. Contractor and the City shall renegotiate the terms and conditions upon renewal for an additional one (1) year term prior to the date of termination.

3. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.
