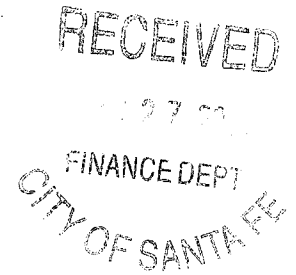


**CITY OF SANTA FE  
AMENDMENT No. 1 TO  
PROFESSIONAL SERVICES AGREEMENT  
To Agreement # 15-0858**



AMENDMENT No. 1 (the "Amendment") to the CITY OF SANTA FE PROFESSIONAL SERVICES AGREEMENT, dated August 26, 2015 (the "Agreement"), between the City of Santa Fe (the "City") and Wunderlich-Malec (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City.

**RECITALS**

A. Under the terms of the Agreement, Contractor has agreed to provide Engineering services to the City for the SCADA Engineering & Support Services.

B. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. COMPENSATION.

Article 3, paragraph A of the Agreement is amended to increase the amount of compensation by a total of three hundred eighty four thousand four hundred dollars (\$384,400) plus applicable gross receipts tax, so that Article 3, paragraph A reads in its entirety as follows:

A. The City shall pay to the Contractor in full payment for services rendered a sum not to exceed five hundred eighty four thousand four hundred dollars (\$584,400), plus applicable gross receipts taxes.

Fiscal Year 2015 – 2016, fifty thousand dollars (\$50,000) plus applicable gross receipts taxes

Fiscal Year 2016 – 2017, fifty thousand dollars (\$50,000) plus applicable gross receipts taxes

Fiscal Year 2017 – 2018, four hundred thirty four thousand four hundred dollars (\$434,400) plus applicable gross receipts taxes

Fiscal Year 2018 – 2019, fifty thousand dollars (\$50,000) plus applicable gross receipts taxes

The total amount for the four (4) years will be for services rendered to the City.

B. The Contractor shall be responsible for payment of gross receipts taxes levied by the State of New Mexico on the sums paid under this Agreement.


C. Payment shall be made upon receipt and approval by the City of detailed statements containing a report of services completed. Compensation shall be paid only for services actually performed and accepted by the City.

2. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.

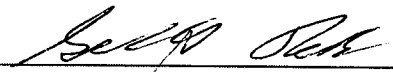
