## CITY OF SANTA FE AMENDMENT No. 2 TO PROFESSIONAL SERVICES AGREEMENT

AMENDMENT No. 2 (the "Amendment") to the CITY OF SANTA FE PROFESSIONAL SERVICES AGREEMENT, dated February 22, 2017 (the "Agreement"), between the City of Santa Fe (the "City") and McHard Accounting Consulting, LLC. (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor whichever occurs last.

#### **RECITALS:**

- A. Under the terms of the Agreement, Contractor has agreed to provide a Fraud Prevention Engagement for the City.
- B. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

### 1. <u>SCOPE OF SERVICES</u>

Article 1 of the Agreement is amended to add additional services, so that Article 1, paragraph C reads as follows:

- C. Response to Inspection of Public Records.
- 2. COMPENSATION.

Article 3, paragraph A of the Agreement is amended to increase the amount of compensation by a total of one thousand five hundred ninety-two dollars and sixty-one cents (\$1,592.61), so that Article 3, paragraph A reads in its entirety as follows:

A. The City shall pay to the Contractor in full payment for services rendered, a sum not

to exceed fifty-one thousand five hundred ninety-two dollars and sixty-one cents (\$51,592.61) plus applicable New Mexico gross receipts tax, mileage and any out-of-pocket expenses with prior approval by the City.

### 3. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.
