MEMORANDUM OF UNDERSTANDING Between the **NEW MEXCIO DEPARTMENT OF PUBLIC SAFETY** And CITY OF SANTA FE/EOD

Parties ١.

> The Parties to this agreement are the NEW MEXICO DEPARTMENT OF PUBLIC SAFETY and the CITY OF SANTA FE/EOD.

II. **Purpose**

> This Memorandum of Understanding (MOU) is entered into by the New Mexico Department of Public Safety and the City of Santa Fe / EOD will authorize the City of Santa Fe to install NMDPS frequencies in City of Santa Fe/EOD communication assets to facilitate tactical communication interoperability among NMDPS, City of Santa Fe/EOD.

III. Responsibilities

The City of Santa Fe will ensure that all users understand and comply with this agreement.

The City of Santa Fe is responsible for procurement, maintenance and programming of their own radios and support equipment.

The City of Santa Fe shall adhere to all FCC regulations and accepted local radio protocols.

NMDPS will provide the City of Santa Fe/EOD a list of frequencies authorized for use (see attachment).

Use shall be limited solely to communications between City of Santa Fe and the NMDPS on matters related to safety, search, rescue, law enforcement and environmental protection activities.

IV. Other Provisions

> Nothing in this Agreement is intended to conflict with current law or regulation or the directives of NMDPS or the City of Santa Fe/EOD. If a term of this agreement is inconsistent with such authority, that term shall be invalid. The remaining terms and conditions of this agreement shall remain in full force and effect.

All radio transmissions must be in the clear mode using plain language. Personnel will continue to use their respective call signs when contacting a communication center or other agency entities.

This document is an inter-agency agreement among the Parties and does not create or confer any rights, privileges, or benefits upon any person or entity not a signatory hereto. This MOU is not and shall not be construed as a rule or regulation.

٧. **Effective Date**



The terms of this agreement will be effective upon the date of the last signature executing this agreement.

VI. Modification

This agreement may be modified upon the mutual written consent of the Parties involved. Termination

The terms of this agreement, as modified with the consent of both Parties, will remain in effect for 5 years upon signature by both Parties. The agreement may be extended or renewed by mutual written agreement of the Parties every five years. Either Party upon 30 day's written notice to the other Party may terminate this agreement.

VII. Frequencies
