AMENDMENT #2 (the "Amendment") to the CITY OF SANTA FE PROFESSIONAL SERVICES AGREEMENT dated October 12, 2017, (the "Agreement"), between the City of Santa Fe (the "City") and Debbie Widrick (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor whichever occurs last.

**RECITALS**

A. Under the terms of the Agreement, Contractor has agreed to provide:  
Teach/Instruct a minimum of three (3) Pilate Fusion classes weekly at the Ft. Marcy Complex, 490 Bishop's Lodge Road, Santa Fe, NM, 87501

Will teach/Instruct a minimum of Three (3) Classes as determined by the Program Supervisor.

B. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. SCOPE OF SERVICES:

Article 1 of the Agreement is amended to increase the amount of Pilates Fusion Classes to three (3) classes, so Article 1 reads as follows:

- A. Teach/Instruct between a minimum of three (3) Pilates Fusion  
Classes per week and occasional subbing for Body Sculpt and Senior  
Low Impact Aerobics at the Fort Marcy Recreation Center, 490 Bishops

Lodge Rd., Santa Fe, NM, 87501. Classes are as follows: Pilates Fusion, Body Sculpt and Senior Low Impact Aerobics. Teach/Instruct a minimum of ten (10) classes, 1 class per week for 5 weeks, at 2 City of Santa Fe locations as determined by the Wellness Coordinator. Classes are as follows PIYO; and High Intensity Fitness Fusion.

2. COMPENSATION:

Article 3, paragraph A of the Agreement is amended to increase the compensation by Five Thousand Nine Hundred Seventy Seven Dollars and Sixty Two Cents (\$5,977.62) at Ft Marcy Complex so that Article 3, paragraph A reads as follows:

A. The City shall pay to the Contractor in full payment for services rendered, a sum not to exceed eighteen thousand four hundred seventy-nine dollars and thirty-two cents (\$18,479.32), inclusive of gross receipts taxes at the current rate of 8.4375% Payment shall be made for services actually rendered at a rate of thirty dollars (\$ 30.00) per hour at Ft. Marcy.

3. TERM:

Article 5 of the Agreement is hereby deleted. A new Article 5 of the Agreement is inserted to extend the term of the Agreement, so that Article 5 reads in its entirety as follows:

This Agreement shall be effective when signed by the City and shall terminate on June 30, 2019, unless terminated sooner pursuant to Paragraph 6, below.

4. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.


