AMENDMENT No. 2 TO  
SERVICES AGREEMENT

This AMENDMENT No. 2 (the "Amendment") amends the CITY OF SANTA FE PROFESSIONAL SERVICES AGREEMENT, dated September 19, 2016 (the "Agreement"), between the City of Santa Fe (the "City") and Territorial Lock and Safe. (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor whichever occurs last.

**RECITALS:**

A. Under the terms of the Agreement, Contractor has agreed to provide Locksmith Services for SFCCC.

B. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. COMPENSATION.

Article 3, paragraph A of the Agreement is amended to increase the amount of compensation by a total of six thousand dollars (\$6,000.00), inclusive of gross receipts taxes, so that Article 3, Paragraph A reads in entirety as follows:

A. The City shall pay the Contractor in full payment for services rendered, a sum not to exceed nine thousand dollars (\$9,000.00), inclusive of applicable gross receipts taxes. Payment breakdown is as follows:

\$3000.00      16/17

\$3000.00      17/18

3000.00 18/19

2. TERM

Article 5 of the Agreement is hereby amended so that article 5, reads in its entirety as follows:



IN WITNESS WHEREOF, the parties have executed this Amendment No.2 to the City of Santa Fe Professional Services Agreement as of the dates set forth below.


