AMENDMENT No. 1 TO  
TEAM BROADCASTING, INC. PROFESSIONAL SERVICES AGREEMENT  
ITEM#17-0732**

This AMENDMENT No.1 (the "Amendment") amends the CITY OF SANTA FE PROFESSIONAL SERVICES AGREEMENT, dated July 11, 2017 (the "Agreement"), between the City of Santa Fe (the "City") and The Team Broadcasting, Inc.. dba: KQTM 101.7 FM The Team (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor whichever occurs last.

**RECITALS:**

A. Under the terms of the Agreement, Contractor has agreed to provide the City with advertisement, promoting and marketing the Parks & Recreation Department, to qualified markets via radio advertising as requested by the City.

B. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. COMPENSATION.

Article 3, paragraph A of the Agreement is amended to increase the amount of compensation by a total of seven thousand nine hundred and twenty dollars (\$7,920.00) inclusive of applicable gross receipts taxes, so that Article 3, paragraph A reads in its entirety as follows:

A. The City shall pay the Contractor in full payment for services rendered, a sum not to exceed fifteen thousand eight hundred and forty dollars (\$15,840.00), inclusive of applicable gross receipts taxes.

The compensation breakdown is as follows:

FY17/18 \$7,920.00

FY18/19 \$7,920.00

2. TERM:

Article 5 of the Agreement is hereby deleted in its entirety and substitute the following Article 5 in its place:

This Agreement shall be effective when signed by the City and shall terminate on June 30, 2019, unless amended in writing to renew the Agreement for up to two (2) additional one-year terms, not to exceed four (4) years total, including all extensions and renewals or unless terminated sooner pursuant to Article 6 of the Agreement.

3. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.

IN WITNESS WHEREOF, the parties have executed this Amendment No. 1 to the City of Santa Fe Professional Services Agreement as of the dates set forth below.


