AMENDMENT No. 3 (the "Amendment") to the CITY OF SANTA FE PROFESSIONAL SERVICES AGREEMENT Item# 16-0888, dated September 21, 2016 (the "Agreement"), between the City of Santa Fe (the "City") and Raymond D. Ortega (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor whichever occurs last.

RECITALS

A. Under the terms of the Agreement, Contractor has agreed to provide additional Teach/Instruct Aqua Zumba Classes at Salvador Perez Pool;

B. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. SCOPE OF SERVICES:

Article 1 of the Agreement is amended, so that Article 1 reads as follows:

Teach/Instruct 4 Aqua Zumba Classes per week at Salvador Perez and 1 Zumba Class at Genoveva Chavez Community Center.

2. COMPENSATION:

Article 3 of the Agreement is amended to increase the compensation by six thousand eighteen dollars and twenty eight cents (\$6,018.28) at Salvador Perez at 185 hours and One Thousand Eight Hundred Ninety Seven Dollars and Sixty Six Cents

(\$1,897.66) at Genoveva Chavez Community Center so that Article 3 reads as follows:

The City shall pay to the contractor in full payment for services rendered a sum not to exceed Nineteen Thousand Nine Dollars and Twelve Cents (\$19,009.12) inclusive of gross receipts tax at the current rate of 8.4375%. Payment shall be made for services actually rendered at a rate of Thirty Dollars (\$30.00) per hour at Salvador Perez Pool and Thirty Five Dollars (\$35.00) per hour at Genoveva Chavez Community Center

3. TERM:

Article 5 of the Agreement is hereby deleted. A new Article 5 of the Agreement is inserted to extend the term of the Agreement, so that Article 5 reads in its entirety as follows:

This Agreement shall be effective when signed by the City and shall terminate on June 30, 2019, unless terminated sooner pursuant to Paragraph 6, below.

4. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.
