CITY OF SANTA FE AMENDMENT No. 1 TO PROFESSIONAL SERVICES AGREEMENT ITEM# 17-1296

This AMENDMENT No. 1 (the "Amendment") amends the CITY OF SANTA FE
PROFESSIONAL SERVICES AGREEMENT, dated November 29, 2017 (the "Agreement"),
between the City of Santa Fe (the "City") and Southwest Propane. (the "Contractor"). The date of
this Amendment shall be the date when it is executed by the City and the Contractor whichever
occurs last.

RECITALS:

- A. Under the terms of the Agreement, Contractor has agreed to provide Propane and delivery to Environmental Services Division, located at 1142 Siler in Santa Fe County. Pricing is based on Exhibit "A" attached and incorporated herein.
- B. Pursuant to Article 19 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. <u>COMPENSATION</u>.

Article 3, paragraph A of the Agreement is amended to increase the amount of compensation by a total of five thousand dollars (\$5,000) so that Article 3, paragraph A reads in its entirety as follows:

A. The City shall pay to the Contractor in full payment for services rendered a sum not to exceed thirteen thousand dollars (\$13,000), inclusive of applicable gross receipts taxes. Payment shall be made for services actually rendered at a rate of one dollar and fifty five (\$1.55) cents per gallon effective November 1, 2018 based on Exhibit "A-1" attached hereto and

incorporated herein.

2. TERM:

Article 5 of the Agreement is hereby deleted in its entirety and substitute the following

This Agreement shall be effective when signed by the City and the Contractor, whichever occurs

last, and shall terminate on October 31, 2019 unless sooner pursuant to article (7) below.

4 OPTION TO RENEW

Article 6 of the Agreement is hereby deleted in its entirety and substitute the following

A. Contractor is granted, upon a satisfactory performance, an option to renew this Agreement for two (2) additional one (1) year period, not to exceed four (4) years. Contractor and City shall renegotiate the term and conditions upon renewal. The option shall be exercised by the parties prior to the expiration date of this Agreement.

5. NOTICE

Article 23 of the Agreement is hereby revised, so that Article 23 reads as follows:
