# CITY OF SANTA FE AMENDMENT No. 2 TO PROFESSIONAL SERVICES AGREEMENT ITEM#16-0984

This AMENDMENT No. 2 (the "Amendment") amends the CITY OF SANTA FE
PROFESSIONAL SERVICES AGREEMENT, dated October 13, 2017 (the "Agreement"),
between the City of Santa Fe (the "City") and Purcell Tire and Service Center. (the "Contractor").
The date of this Amendment shall be the date when it is executed by the City and the Contractor whichever occurs last.

#### **RECITALS:**

- A. Under the terms of the Agreement, Contractor has agreed to provide the tire recapping services.
- B. Pursuant to Articles 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

#### 1.. COMPENSATION.

Article 3, paragraph A of the Agreement is amended to increase the amount of compensation by forty-five thousand dollars (\$45,000), so that Article 3, paragraph A reads in its entirety as follows:

A. The City shall pay to the Contractor in full payment for services rendered a sum not to exceed three hundred thousand dollars (\$300,000), plus applicable gross receipts taxes. Payment shall be made for services actually rendered at a rate as explained in Exhibit "A, A-1, A-2" attached and incorporated herein.

## 2. <u>TERM:</u>

Article 5, of the Agreement is hereby deleted in its entirety and substitute the following Article 5, in its place:

This Agreement shall be effective when signed by the City and shall terminate on September 30, 2019.

### 3. OPTION TO RENEW

Article 6, of the Agreement is hereby deleted in its entirety and substitute the following Article 6, in its place:

Contractor is granted, upon a satisfactory performance, an option to renew this Agreement for one (1) additional one (1) year period not to exceed four (4) years. Contractor and City shall renegotiate the terms and conditions upon renewal. The option shall be exercised by the parties prior to the expiration date of this Agreement.

### 4. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.
