ORDER DETAILS

This Addendum shall modify and supersede as indicated certain terms and provisions of the Software Agreement between the City of Santa Fe, NM (the "Customer") and OPENGOV, INC. ("OpenGov"), effective September 25, 2015 (the "Agreement"). The Customer and OpenGov have mutually agreed that the following modifications be made to the Agreement.

In consideration of the Customer extending the Services identified as OpenGov Budget Builder for a period of one (1) month, the Customer shall pay OpenGov, Inc. a prorated fee of \$30,383.87 for the period from February 1, 2018 until February 28, 2018.






