### CITY OF SANTA FE AMENDMENT No. 2 TO PROFESSIONAL SERVICES AGREEMENT ITEM #16-0901

AMENDMENT No. 2 (the "Amendment") to the CITY OF SANTA FE PROFESSIONAL SERVICES AGREEMENT, dated October 5, 2016 (the "Agreement"), between the City of Santa Fe (the "City") and Municipal Code Corporation (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor, whichever occurs last.

### **RECITALS**

- A. Under the terms of the Agreement, Contractor has agreed to provide codification and publication services to the City for the Santa Fe City Code of Ordinances.
- B. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

# 1. <u>COMPENSATION</u>

Article 3, Paragraph A of the Agreement is amended to increase the total compensation amount by fifteen thousand dollars (\$15,000), plus applicable gross receipts taxes, so that Article 3, Paragraph A reads in its entirety as follows:

A. The City shall pay the Contractor in full payment for services rendered, a sum not to exceed thirty-five thousand dollars (\$35,000), plus applicable gross receipts taxes, during the term of this Agreement.

#### 2. TERM AND EFFECTIVE DATE.

Article 5 of the Agreement is amended to extend the Term of the Agreement to September 30, 2019, so that Article 5 reads in its entirety as follows:

This Agreement shall be effective when signed by the City and terminate on September 30, 2019, unless terminated sooner pursuant to Article 6 below. The term of this Agreement may be extended for an additional period of one (1) year, not to exceed four (4) years, by a written amendment in accordance with the terms of this Agreement.

#### 2. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.
