AMENDMENT No. 1 (the "Amendment") to the CITY OF SANTA FE PROFESSIONAL SERVICES AGREEMENT, dated November 30, 2018 (the "Agreement"), between the City of Santa Fe (the "City") and B&D Industries, Inc (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor whichever occurs last.

RECITALS

A. Under the terms of the Agreement, Contractor has agreed to provide Plant Extended Gas Line Replacement and Upgrade services to the City of Santa Fe at the Waste Water Treatment Plant Facility.

B. Pursuant to Article 8 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. COMPENSATION.

Article 3, paragraph 1 of the Agreement is amended to increase the amount of compensation by a total of one hundred forty three thousand nine hundred seventy-seven dollars and eighty-four cents (\$143,977.84) including NMGRT, so that Article 1, paragraph 3, paragraph 1 reads in its entirety as follows:

The City shall pay to the Contractor based upon fixed prices for each Deliverable item as listed here.

The total compensation under this Agreement shall not exceed **\$209,040.34 - including New Mexico gross receipts tax.**

AGREEMENT IN FULL FORCE.


