AMENDMENT No.1 (the "Amendment") to the CITY OF SANTA FE COST SHARE AGREEMENT, dated August 26, 2015 the "Agreement"), between the City of Santa Fe (the "City") and USDA, Forest Service. (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor whichever occurs last.

RECITALS

A. Under the terms of the Agreement, Contractor and the City have agreed to cooperate and provide means to support the protection of the Santa Fe Watershed.

B. Pursuant to Article X of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. COMMENCEMENT/EXPIRATION DATE:

Article X of the Agreement is hereby deleted. A new Article X of the Agreement is inserted to extend the term of the Agreement, so that Article X reads in its entirety as follows:

This award is executed as of the date of the last signature and is effective through October 30, 2019.

2. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.
