CITY OF SANTA FE AMENDMENT No. 1 TO PROFESSIONAL SERVICES AGREEMENT

AMENDMENT No. 1 (the "Amendment") to the CITY OF SANTA FE
PROFESSIONAL SERVICES AGREEMENT (#17-0320), date April 21, 2017 (the
"Agreement"), between the City of Santa Fe (the "City") and Tetra Tech, Inc. (the
"Contractor"). The date of this Amendment shall be the date when it is executed by the
City and the Contractor whichever occurs last.

RECITALS

- A. Under the terms of the Agreement, Contractor has agreed to provide professional services for the City of Santa Fe.
- B. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. SCOPE OF SERVICES

Article 1, paragraph A of the Agreement is amended to include additional professional engineering services for the City so that Article 1, paragraph A is amended to read in its entirety as follows:

A. The Contractor shall provide professional engineering services for the City with regards to Stormwater Management Plan for the City of Santa Fe ("The Project"), in accordance with all provisions of its contract and the attached proposal as outlined in Exhibit "A-1", attached hereto and made a part thereof.

2. <u>COMPENSATION.</u>

Article 3, paragraph A of the Agreement is amended to increase the amount of compensation by a total of four hundred thirteen thousand and two hundred dollars and no cents (\$413,200.00) exclusive of New Mexico gross receipts taxes, so that Article 3, paragraph A reads in its entirety as follows:

A. The City shall pay to the Contractor (Item # 17-0320, Exhibit A-1) in full payment for services rendered, a sum not to exceed six hundred twenty-six thousand ninety-five dollars and sixty-three cents (\$626,095.63) exclusive of New Mexico gross receipts taxes for the term of this agreement.

3. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.
