

**CITY OF SANTA FE
AMENDMENT No. 1 TO
PROFESSIONAL SERVICES AGREEMENT
ITEM#18-0609**

This AMENDMENT No.1 (the "Amendment") amends the CITY OF SANTA FE PROFESSIONAL SERVICES AGREEMENT, dated June 13, 2018 (the "Agreement"), between the City of Santa Fe (the "City") and Youth Works. (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor whichever occurs last.

RECITALS:

- A. Under the terms of the Agreement, Contractor has agreed to provide Intensive Community Monitoring services.
- B. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

COMPENSATION.

Article 3, paragraph A of the Agreement is amended to decrease the amount of compensation by a total of forty three thousand dollars (\$43,000.00) so that Article 3, paragraph A reads in its entirety as follows:

- A. The City shall pay to the Contractor in full payment for services rendered, a sum not to exceed fourteen thousand two hundred dollars (\$14,200.00), inclusive of applicable gross receipts taxes.

Exhibit B in the contract shall be amended to reflect the decrease and billing of contracted services as:

A. INTAKE:	\$40.00	x	28 Youth	=	\$1,120.00
CLIENT SUPPORT:	\$40.00	x	197.75 Hours	=	\$7,910.00
FAMILY SUPPORT:	\$40.00	x	37.00 Hours	=	\$1,480.00
CASE MANAGEMENT:	\$40.00	x	65.75 Hours	=	\$2,630.00
FINAL COURT REPORT:	\$40.00	x	26.5 Youth	=	\$1,060.00

2 AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.

IN WITNESS WHEREOF, the parties have executed this Amendment No. 1 to the City of Santa Fe Professional Services Agreement as of the dates set forth below.




