

**CITY OF SANTA FE
AMENDMENT No. 1 TO
PROFESSIONAL SERVICES AGREEMENT
ITEM#18-0608**

This AMENDMENT No. 1 (the "Amendment") amends the CITY OF SANTA FE PROFESSIONAL SERVICES AGREEMENT, dated May 30, 2018 (the "Agreement"), between the City of Santa Fe (the "City") and Communities in Schools. (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor whichever occurs last.

RECITALS:

A. Under the terms of the Agreement, Contractor has agreed to provide Educational Wrap Around services to 146 unduplicated youth.

B. Pursuant to Article 18 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. SCOPE OF SERVICES

Article 1 of the Agreement is amended to include the following: Ortiz Middle School students ages 10-17, so that Article 1 reads as follows:

The Contractor shall provide Educational Wrap Around services at Caesar Chavez Elementary School, Ortiz Middle School and Capital High School students ages 10-17 described in Exhibit "A" attached hereto and incorporated herein.

2. COMPENSATION.

Article 3, paragraph A of the Agreement is amended to decrease the amount of compensation by a total of twenty dollars (\$20.00) so that Article 3, paragraph A reads in its

entirety as follows:

A. The City shall pay to the contractor in full payment for services rendered, a sum not to exceed of forty eight thousand one hundred and sixty dollars (\$48,160.00), inclusive of applicable gross receipts taxes.

Exhibit B in the Agreement shall be amended to reflect the decrease and billing of contracted services as:


A. INTAKE:	\$40.00	x 146 Hours =	\$5,840.00
IMPLEMENTATION:	\$40.00	x 146 Hours =	\$5,840.00
CLIENT SUPPORT:	\$40.00	x 304 Hours =	\$12,160.00
FAMILY SUPPORT:	\$40.00	x 304 Hours =	\$12,160.00
CASE MANAGEMENT:	\$40.00	x 304 Hours =	\$12,160.00

3. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.


