# CITY OF SANTA FE AMENDMENT No. 3 TO CONSTRUCTION AGREEMENT #16-0704; #17-0452; #18-0551

AMENDMENT No. 3 (the "Amendment") to the CITY OF SANTA FE Agreement, dated July 27, 2016 (the "Agreement"), between the City of Santa Fe (the "City") and TLC Plumbing & Utility, Inc., (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor, whichever occurs last.

#### **RECITALS**

- A. Under the terms of the Agreement, Contractor has agreed to provide City Wide Water Utility Pavement Restoration services to the City.
- B. Pursuant to Article 9.21 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

# 1. <u>COMPENSATION.</u>

Article 4, paragraph 4.1 of the Agreement is amended to increase the amount of compensation for services for fiscal year 2018/2019 by a total two hundred and sixteen thousand six hundred twenty five dollars (\$216,625), inclusive of gross receipts tax so that Article 4, paragraph 4.1 reads as follows:

4.1 The Owner shall pay the Contractor in current funds for the performance of each Work Order at the fixed unit prices set forth in Exhibit I, subject to additions and deductions by Change Order as provided in the Contract Documents, up to the Contract Sum of eight hundred sixty six thousand five hundred dollars (\$866,500) including New Mexico Gross Receipts Tax.

### 2. <u>TERM.</u>

Article 8 of the Agreement is amended to extend the term of the Agreement to June 30, 2020.

## 3. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.
