AMENDMENT No. 1 (the "Amendment") to the CITY OF SANTA FE CONTRACT, dated September 5, 2018 (the "Agreement"), between the City of Santa Fe (the "City") and Univar USA, Inc. (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City.

RECITALS

A. Under the terms of the Agreement, Contractor has agreed to supply and deliver Hi-Grade Evaporated Salt as outlined in the original Agreement to the City.

B. Pursuant to Article 8 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. COMPENSATION.

Article 3 of the Agreement is amended as follows:

The City shall pay to the Contractor based upon fixed prices for each Deliverable item as listed here.

Deliverable item:	U/I (unit of issue)	per lb	Price
Estimate 300,000 lbs			\$0.920
Fiscal 2019-2020, fifty seven thousand six hundred dollars (\$57,600), excluding applicable gross receipts taxes.			
Fiscal 2020-2021, fifty seven thousand six hundred dollars (\$57,600), excluding applicable gross receipts taxes.			
Fiscal 2021-2022, fifty seven thousand six hundred dollars (\$57,600), excluding applicable gross receipts taxes.			

The total compensation under this Agreement shall not two hundred thirty thousand four hundred dollars (\$230,400), excluding New Mexico gross receipts

tax.

2. TERM.

THIS AGREEMENT SHALL NOT BECOME EFFECTIVE UNTIL APPROVED IN WRITING BY THE CITY. This Agreement shall begin on date approved by the City, and end on June 30, 2022. The City reserves the right to renew the contract on an annual basis by mutual Agreement not exceed a total of four years in accordance with NMSA 1978, §§ 13-1-150 through 152.

3. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.

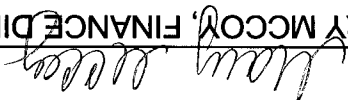

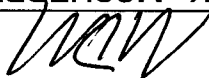
