CITY OF SANTA FE AMENDMENT NO. 1 TO PROFESSIONAL SERVICES CONTRACT

AMENDMENT No. 1 (the "Amendment") to the CITY OF SANTA FE PROFESSIONAL SERVICES CONTRACT #19-0204 between the City of Santa Fe (the City) and Teppics Engineering, LLC, (the Contractor). The date of this Amendment shall be the date when it is executed by the City and the Contractor, whichever occurs last.

RECITALS

- A. Under the terms of the Agreement, the Contractor shall provide numerical analysis of the flow of electrical power at the Mary Esther Gonzales Senior Center located at 1121 Alto Street, Santa Fe, New Mexico.
- B. Pursuant to Article 13 of the Agreement, and for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City and the Contractor agree as follows:

1. TERM.

Article 3, of the Agreement is amended to extend the contract's termination date to June 30, 2020, so that Article 3, reads as follows:

THIS AGREEMENT SHALL NOT BECOME EFFECTIVE UNTIL APPROVED BY THE CITY. This Agreement shall terminate on June 30, 2020 unless terminated pursuant to paragraph 4 (Termination), or paragraph 5 (Appropriations). In accordance with Section 13-1-150 NMSA 1978, no contract term for a professional services contract, including extensions and renewals, shall exceed four years, except as set forth in Section 13-1-150 NMSA 1978.

2. AGREEMENT IN FULL FORCE.

Except as specifically provided in Amendment No. 1, the Agreement remains and shall remain in full force and effect, in accordance with its terms.
