AMENDMENT No. 1 TO  
COMMUNITY DEVELOPMENT BLOCK GRANT CONTRACT  
ITEM #19-0343**

AMENDMENT No. 1 (the "Amendment") to the Contract, dated April 24, 2019 (the "Agreement"), between the City of Santa Fe (the "City") and Coming Home Connection (the "Contractor"). The date of this Amendment shall be the date when it is executed by the City and the Contractor, whichever occurs last.

**RECITALS**

1. The Subrecipient has applied for and received funds from the United States Government under Title 1 of the Housing and Community Development Act of 1974, Public Law 93-383.
2. The City desires to engage the Subrecipient to render certain services to the City and its citizens.
3. The Subrecipient further certified that it is willing and able to perform these services and that said services to be performed are within the Subrecipient's legal powers and capabilities.
4. The City desires to engage the Subrecipient to render these certain services in connection therewith as more particularly set forth hereafter.
5. The Subrecipient, Coming Home Connection will render the services and New Mexico Community Foundation will serve as the Fiscal Agent.

1. **FISCAL AGENT**

Article X of the Agreement is hereby deleted. A new Article X of the Agreement is inserted, so that Article X reads in its entirety as follows:

The New Mexico Community Foundation will act as Coming Home's Fiscal Agent and will defend, indemnify and hold harmless the City from any and all liability, costs and expenses whatsoever for expenditure of funds pursuant to the Scope of Services of this Contract

2. AGREEMENT IN FULL FORCE.

Except as specifically provided in this Amendment, the Agreement remains and shall remain in full force and effect, in accordance with its terms.




